AMENDMENTS TO SENATE BILL NO. 329

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike "Contesting" and substitute "Requesting an Investigation"; in line 5, strike "contest" and substitute "request an investigation"; in line 7, after "compliance" insert "with the most recent court order"; in line 8, after "payments;" insert "requiring the Child Support Enforcement Administration to send a copy of the obligor's request for an investigation to the obligee, give the obligee a reasonable opportunity to respond, and consider the obligee's response;"; strike beginning with "establishing" in line 10 down through "hearing;" in line 15 and substitute "making it discretionary, rather than mandatory, for the Child Support Enforcement Administration to send a notice to the Motor Vehicle Administration;"; and strike in their entirety lines 22 through 26, inclusive.

AMENDMENT NO. 2

On page 2, in line 9, strike "shall" and substitute "MAY".

AMENDMENT NO. 3

On page 2, in line 25, strike "contest"; in lines 26 and 27, strike "THE PROPOSED ACTION OF THE ADMINISTRATION" and substitute "<u>REQUEST AN INVESTIGATION</u>"; strike beginning with the first "THE" in line 30 down through the first "THE" in line 33; and in line 35, strike "AND THE OBLIGOR DOES NOT HAVE THE PRESENT".

On page 3, strike beginning with "ABILITY" in line 1 down through "DRIVE" in line 2; in line 3, strike "4." and substitute "3."; in the same line, strike "THAT THE"; strike beginning with the first "THE" in line 5 down through "DRIVE" in line 7 and substitute "OF THE OBLIGOR'S:

A. <u>DOCUMENTED DISABILITY RESULTING IN A VERIFIED</u>

INABILITY TO WORK; OR

B. INABILITY TO COMPLY WITH THE COURT ORDER";

in line 8, strike "contest" and substitute "REQUEST AN INVESTIGATION OF"; in line 11, strike "as to the"; strike beginning with "EXISTENCE" in line 12 down through "OBJECTION" in line 13 and substitute "TO DETERMINE IF ANY OF THE GROUNDS UNDER PARAGRAPH (1)(I) OF THIS SUBSECTION EXIST"; in line 33, strike "or" and substitute a comma; and in line 34, after "months," insert "OR THE ADMINISTRATION FINDS THAT ONE OF THE GROUNDS UNDER PARAGRAPH (1)(I) OF THIS SUBSECTION EXISTS,".

On pages 4 and 5, strike in their entirety the lines beginning with line 4 on page 4 through line 24 on page 5, inclusive.

AMENDMENT NO. 4

On page 3, after line 13, insert:

"(II) THE ADMINISTRATION SHALL:

- 1. SEND A COPY OF THE OBLIGOR'S REQUEST FOR AN INVESTIGATION TO THE OBLIGEE BY FIRST-CLASS MAIL;
- 2. <u>GIVE THE OBLIGEE A REASONABLE OPPORTUNITY</u>
 TO RESPOND; AND
 - <u>3.</u> <u>CONSIDER THE OBLIGEE'S RESPONSE.";</u>

and in line 14, strike "(ii)" and substitute "(III)".
