A BILL ENTITLED

1 AN ACT concerning

2 **Election Law - Voting Systems - Voter-Verified Paper Records**

3 FOR the purpose of requiring that certain voting systems produce a paper record of a
4 voter's ballot choices and provide the voter with an opportunity to inspect the
5 paper record; requiring that the paper records be preserved at the polling place
6 in a certain manner so that the paper records may later be used in a manual
7 recount if necessary; requiring the State Board of Elections to conduct a
8 comparison of certain ballots in a random sampling of election districts; and
9 generally relating to voting systems.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article - Election Law**

23 1-101.

24 (s) (1) "Document ballot" means a ballot used with a voting system in which
25 the voter individually is issued a ballot on which to indicate one or more votes.

26 (2) "Document ballot" includes:

1 (i) a machine-read ballot, such as an optically scanned ballot or
2 punchcard ballot; and

3 (ii) a hand-counted paper ballot.

5 (A) (1) ANY VOTING SYSTEM THAT DOES NOT USE A DOCUMENT BALLOT
6 SHALL PRODUCE A PAPER RECORD THAT SHALL BE MADE AVAILABLE FOR
7 INSPECTION AND VERIFICATION BY THE VOTER AT THE TIME THE VOTE IS CAST.

8 (2) THE VOTER-VERIFIED PAPER RECORD SHALL BE PRESERVED
9 WITHIN THE POLLING PLACE IN THE MANNER THAT ALL OTHER DOCUMENT
10 BALLOTS ARE PRESERVED WITHIN THE POLLING PLACE ON ELECTION DAY FOR
11 LATER USE IN ANY MANUAL RECOUNT.

12 (B) A VOTER WHO RECEIVES A VOTER-VERIFIED PAPER RECORD IN
13 ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION MAY REVIEW THE
14 PERMANENT PAPER RECORD AND CORRECT ANY ERROR MADE BY THE SYSTEM
15 BEFORE THE PAPER RECORD IS PRESERVED FOR USE IN ANY MANUAL RECOUNT.

16 (C) THE VOTER-VERIFIED PAPER RECORD PRODUCED UNDER SUBSECTION (A)
17 OF THIS SECTION SHALL BE AVAILABLE AS AN OFFICIAL RECORD AND SHALL BE THE
18 OFFICIAL RECORD USED FOR ANY RECOUNT CONDUCTED WITH RESPECT TO ANY
19 ELECTION WHEN THE SYSTEM IS USED.

20 (D) IN A RANDOM SAMPLING OF 2% OF THE TOTAL NUMBER OF PRECINCTS
21 WITHIN EACH LEGISLATIVE DISTRICT THAT PRODUCE VOTER-VERIFIED PAPER
22 RECORDS, THE STATE BOARD SHALL COMPARE THE VOTER-VERIFIED PAPER
23 RECORDS AGAINST THE ELECTRONICALLY RECORDED RESULTS IN THOSE DISTRICTS
24 TO VERIFY THAT THE ELECTRONICALLY RECORDED RESULTS EQUAL THE
25 VOTER-VERIFIED PAPER RECORDS.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 October 1, 2004.
