3 FOR the purpose of prohibiting a person from misrepresenting the geographic

- 4 location of a business in a local telephone directory or directory assistance
- 5 database; providing that a listing in a local telephone directory or directory
- 6 assistance database is a misrepresentation of the geographic location of a
- 7 business under certain circumstances; providing that this Act is not applicable
- 8 to a local telephone directory publisher or provider of a directory assistance
- 9 database under certain circumstances; and generally relating to
- 10 misrepresentation of geographic location in a local telephone directory or
- 11 directory assistance database.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

21 (A) A PERSON MAY NOT MISREPRESENT THE GEOGRAPHIC LOCATION OF A
22 BUSINESS IN A LOCAL TELEPHONE DIRECTORY OR DIRECTORY ASSISTANCE
23 DATABASE.

24 (B) A PERSON IS CONSIDERED TO MISREPRESENT THE GEOGRAPHIC 25 LOCATION OF A BUSINESS IF:

26 (1) A LOCAL TELEPHONE DIRECTORY LISTING OR DIRECTORY
 27 ASSISTANCE DATABASE ENTRY INCLUDES A GEOGRAPHIC LOCATION; AND

1 (2) THE BUSINESS IS NOT LOCATED WITHIN THE GEOGRAPHIC 2 LOCATION INDICATED.

3 (C) A LOCAL TELEPHONE DIRECTORY LISTING OR DIRECTORY ASSISTANCE
4 DATABASE ENTRY IS NOT CONSIDERED TO MISREPRESENT THE GEOGRAPHIC
5 LOCATION OF A BUSINESS IF:

6 (1) THE BUSINESS NAME INCLUDES A GEOGRAPHIC LOCATION;

7 (2) THE BUSINESS HAS MORE THAN ONE OFFICE IN THE STATE; AND

8 (3) THE BUSINESS HAS AT LEAST ONE OFFICE IN THE GEOGRAPHIC 9 LOCATION INDICATED IN THE BUSINESS NAME.

10 (D) A LOCAL TELEPHONE DIRECTORY PUBLISHER OR PROVIDER OF A 11 DIRECTORY ASSISTANCE DATABASE IS NOT LIABLE FOR A VIOLATION OF THIS 12 SECTION UNLESS:

(1) THE LOCAL TELEPHONE DIRECTORY PUBLISHER OR PROVIDER OF A
 DIRECTORY ASSISTANCE DATABASE IS THE SUBJECT OF A LOCAL TELEPHONE
 DIRECTORY LISTING OR DIRECTORY ASSISTANCE DATABASE ENTRY; AND

16 (2) THE LOCAL TELEPHONE DIRECTORY LISTING OR DIRECTORY
 17 ASSISTANCE DATABASE ENTRY VIOLATES SUBSECTION (A) OF THIS SECTION.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2004.
