HOUSE BILL 179 1 **Article 83A - Department of Business and Economic Development** 2 3-301. 3 (a) There is an Office of International Trade within the Department to promote the development of international business activities and opportunities for 5 the citizens of this State. In furtherance of the purpose set forth in subsection (a) of this section, the 6 (b) 7 Office shall: 8 Encourage Maryland businesses to increase international trade (1) 9 activities, with special emphasis on exports, by: 10 (i) Providing informational and consultative services on the 11 international trade process including, but not limited to, market research and 12 selection, marketing techniques and risks, foreign trade laws and regulations, and the 13 availability of private or public financing; 14 Developing publications to facilitate the exchange of product (ii) 15 and services information between Maryland businesses and foreign businesses; 16 In cooperation with local government and the private sector, (iii) initiating and organizing trade missions to and from foreign countries and 18 participation in trade fairs; 19 Establishing an outreach program to small and medium sized 20 businesses with export potential that provides counseling and that utilizes 21 experienced private sector exporters and other qualified individuals; 22 Assisting, where appropriate, in obtaining export related 23 financing through the Maryland Industrial Development Financing Authority and other federal, local, or private programs; and 25 Channeling trade leads and providing a list of prescreened (vi) 26 foreign intermediaries; Encourage and facilitate the participation by Maryland businesses in 28 barter and counter trade transactions and joint venture transactions, where 29 appropriate, by: 30 Providing informational and consultative services on, but not 31 limited to, the necessary components, laws, and regulations involved in these

All contracts and grants shall be subject to the approval of the Secretary or the Secretary's designee. Procurements for services or supplies to be performed or delivered outside the State shall be consistent with, but not subject to, the purposes or requirements of the State Finance and Procurement Article.
