6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 7 MARYLAND, That the Laws of Maryland read as follows:

10 (a) ~~In this title the following words have the meanings indicated:~~

11 (e) "Police officer" means a person who in an official capacity is authorized by
 12 ~~law to make arrests and is:~~

13 (1) ~~a member of the Department of State Police;~~

14 (2) ~~a member of the Police Department of Baltimore City;~~

15 (3) ~~a member of the Baltimore City School Police Force;~~

16 (4) ~~a member of the police department, bureau, or force of a county;~~

17 (5) ~~a member of the police department, bureau, or force of a municipal~~
 18 ~~corporation;~~

19 (6) ~~a member of the Maryland Transit Administration Police Force,~~
 20 ~~Maryland Port Administration Police Force, or Maryland Transportation Authority~~

7 (a) In this section, "federal law enforcement officer" means an officer who
8 may:

9 (1) make an arrest with or without a warrant for violations of the United
10 States Code; and

11 (2) carry firearms in the performance of the officer's duties.

12 (b) (1) Subject to the limitations of paragraph (2) of this subsection, a
13 federal law enforcement officer may:

14 (i) make arrests as set forth in Subtitle 2 of this title; and

15 (ii) execute arrest and search and seizure warrants issued under
16 the laws of the State.

17 (2) A federal law enforcement officer may exercise the powers granted by
18 this subsection when:

19 (i) the federal law enforcement officer is participating in a joint
20 investigation with officials from a State or local law enforcement unit;

21 (ii) the federal law enforcement officer is rendering assistance to a
22 police officer;

23 (iii) the federal law enforcement officer is acting at the request of a
24 local police officer or State Police officer; or

25 (iv) an emergency exists.

26 (c) (1) A federal law enforcement officer who acts under the authority
27 granted by this section shall notify the following persons of an investigation or
28 enforcement action:

29 (i) 1. the chief of police, if any, or chief's designee, when in a
30 municipal corporation;

31 2. the police commissioner or police commissioner's designee,
32 when in Baltimore City;

33 3. the chief of police or chief's designee, when in a county
34 with a county police department, except Baltimore City;

1 (ii) "Citation" does not include an indictment, information, or
2 statement of charges.

3 (3) "Fire marshal" means:

4 (i) the State Fire Marshal;

5 (ii) a Deputy State Fire Marshal; or

6 (iii) as designated under § 6-304 of the Public Safety Article:

7 1. an Assistant State Fire Marshal; or

8 2. a Special Assistant State Fire Marshal.

9 (4) "Police officer" has the meaning stated in § 2-101 of this article.

10 (b) (1) Subject to paragraph (2) of this subsection, in addition to any other
11 law allowing a crime to be charged by citation, a police officer OR UNITED STATES
12 PARK POLICE OFFICER may issue a citation for:

13 (i) sale of an alcoholic beverage to an underage drinker or
14 intoxicated person under Article 2B, § 12-108 of the Code;

15 (ii) malicious destruction of property under § 6-301 of the Criminal
16 Law Article, if the amount of damage to the property is less than \$500;

17 (iii) disturbing the peace or disorderly conduct under § 10-201 of
18 the Criminal Law Article; or

19 (iv) misdemeanor theft under § 7-104(g)(2) of the Criminal Law
20 Article.

21 (2) A police officer OR UNITED STATES PARK POLICE OFFICER may issue
22 a citation to a defendant if the [police] officer is satisfied with the defendant's
23 evidence of identity and reasonably believes that the defendant will comply with the
24 citation.

25 (c) (1) Subject to paragraph (2) of this subsection, in addition to any other
26 law allowing a crime to be charged by citation, a fire marshal may issue a citation for:

27 (i) discharging fireworks without a permit under § 10-104 or §
28 10-110 of the Public Safety Article;

29 (ii) possessing with intent to discharge or allowing the discharge of
30 fireworks under § 10-104 or § 10-110 of the Public Safety Article; or

31 (iii) maintaining a fire hazard under § 6-317 of the Public Safety
32 Article.

1 (2) A fire marshal may issue a citation if the fire marshal is satisfied
2 with the defendant's evidence of identity and reasonably believes that the defendant
3 will comply with the citation.

4 (d) (1) This section does not apply to a citation that is:

5 (i) authorized for a violation of a parking ordinance or a regulation
6 adopted by a State unit or political subdivision of the State under Title 26, Subtitle 3
7 of the Transportation Article;

8 (ii) authorized by the Department of Natural Resources under §
9 1-205 of the Natural Resources Article; or

10 (iii) authorized by Baltimore City under § 16-16A (special
11 enforcement officers) of the Code of Public Local Laws of Baltimore City for violation
12 of a code, ordinance, or public local law of Baltimore City concerning building,
13 housing, health, fire, safety, zoning, or sanitation.

14 (2) Except as otherwise expressly provided by law, the Chief Judge of the
15 District Court shall prescribe a uniform, statewide form of a citation.

16 (3) Except for the uniform motor vehicle citation form, the law
17 enforcement agencies of the State, THE UNITED STATES PARK POLICE, and the Office
18 of the State Fire Marshal shall reimburse the District Court for printing the citation
19 forms that law enforcement officers and the Fire Marshal require.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2004.
