2 Public Safety - Handgun Identification Requirements - Repeal

- 3 FOR the purpose of repealing a certain provision that establishes a certain procedure
- for the collection and reporting of certain handgun shell casing information; and
- 5 generally relating to handgun identification requirements.

- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That the Laws of Maryland read as follows:
- 13 Article Public Safety
- 14 [5-131.
- 15 (a) (1) In this section the following words have the meanings indicated.
- 16 "Manufacturer" means a person who possesses a federal license to
- 17 engage in the business of manufacturing firearms or ammunition for sale or
- 18 distribution.
- 19 (3) "Projectile" means the part of handgun ammunition that is expelled
- 20 through the barrel of the handgun by an explosion.
- 21 "Shell casing" means the part of handgun ammunition that contains
- 22 the primer and propellent powder to discharge the projectile.
- 23 (b) A manufacturer that ships or transports a handgun for sale, rental, or
- 24 transfer in the State shall include in the box with the handgun in a separate, sealed
- 25 container:

1

- (1) a shell casing of a projectile discharged from the handgun; and
- 2 (2) additional information that the Secretary requires to identify the 3 type of handgun and shell casing.
- 4 (1) On receipt of a handgun from a manufacturer, the dealer shall (c) 5 confirm to the Department of State Police that the manufacturer has complied with 6 subsection (b) of this section.
- 7 On the sale, rental, or transfer of the handgun, the dealer shall (2) 8 forward the sealed container to the Department of State Police Crime Laboratory.
- 9 On receipt of a shell casing and information as required in subsection (b) of 10 this section, the Department of State Police Crime Laboratory shall enter the 11 information in each relevant database.]
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 2004.
