- 12 [(f) The cost of the CWBT license for holders of a BWL license is \$350 each
- 13 year in addition to the cost of the BWL license.
- 14 (g) The cost of the WBT license for holders of a BW license is \$100 each year in
- 15 addition to the cost of the BW license.]
- 16 [(h)] (G) The Liquor Control Board may adopt regulations providing
- 17 additional requirements to implement this subsection.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 19 October 1, 2004.
