- 3 SECTION 3. AND BE IT FURTHER ENACTED, That the State Board of

- 5 Nursing, shall adopt regulations necessary to implement this Act.
- 6 SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall
