# 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

16 (a) A person may not cause the death of another as a result of the person's 17 negligently driving, operating, or controlling a motor vehicle or vessel while:

- 18 (1) under the influence of alcohol; or
- 19 (2) under the influence of alcohol per se.
- 20 (b) A violation of this section is:
- 21 (1) homicide by motor vehicle or vessel while under the influence of
- 22 alcohol; or

1 (2) homicide by motor vehicle or vessel while under the influence of 2 alcohol per se.

3 (c) A person who violates this section is guilty of a felony and on conviction is 4 subject to imprisonment not exceeding [5]10 years or a fine not exceeding \$5,000 or 5 both.
