# **Article - Education**

16 18-114.

17 (A) IN THIS SECTION, "FUND" MEANS THE STUDENT FINANCIAL ASSISTANCE 18 FUND.

19 (B) (1) THERE IS A STUDENT FINANCIAL ASSISTANCE FUND IN THE OFFICE.

20 (2) THE FUND IS A CONTINUING, NONLAPSING FUND THAT IS NOT 21 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

22 (3) THE TREASURER SHALL SEPARATELY HOLD AND THE COMPTROLLER 23 SHALL ACCOUNT FOR THE FUND.

24 (4) THE FUND SHALL BE INVESTED AND REINVESTED IN THE SAME 25 MANNER AS OTHER STATE FUNDS.

1 (5) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE PAID INTO 2 THE FUND.

3 (C) THE FUND CONSISTS OF REPAYMENT OBLIGATIONS INCURRED BY
4 RECIPIENTS OF STUDENT FINANCIAL ASSISTANCE, SCHOLARSHIPS, OR GRANTS
5 ADMINISTERED BY THE COMMISSION UNDER THIS TITLE AND PAID TO THE STATE.

6 (D) EXPENDITURES FROM THE FUND SHALL BE MADE BY AN APPROPRIATION
7 IN THE ANNUAL STATE BUDGET OR BY APPROVED BUDGET AMENDMENT AS
8 PROVIDED UNDER § 7-209 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

9 (E) THE MONEY IN THE FUND SHALL BE USED FOR FINANCIAL ASSISTANCE, 10 SCHOLARSHIPS, OR GRANTS ADMINISTERED BY THE COMMISSION UNDER THIS 11 TITLE.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 July 1, 2004.
