FOR the purpose of requiring a dealer to submit certain records by one of two methods, including by electronic computer entry transmittal, in a format acceptable to the receiving law enforcement unit, by a certain time each day, if required by the law enforcement unit; and generally relating to the transfer of records of dealers of precious metal objects. 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

17 (a) (1) A dealer shall submit a copy of each record to the primary law 18 enforcement unit in accordance with subsection (b) of this section.
19 (2) If the dealer transacts business in accordance with § 12-206(b) of this 20 title, the dealer also shall submit a copy of the records to the local law enforcement 21 unit in accordance with subsection (b) of this section.

1 (3) On the request of a dealer, the Secretary shall provide to the dealer a 2 list of local law enforcement units. The dealer shall submit the records by ONE OF THE FOLLOWING 4 METHODS, AS REQUIRED BY THE LAW ENFORCEMENT UNIT: 5 BY delivering or mailing a copy of the records by the end of the next 6 business day after the day on which the item was acquired; OR 7 BY ELECTRONIC COMPUTER ENTRY TRANSMITTING A COPY OF THE (2) 8 RECORDS ELECTRONICALLY, IN A FORMAT ACCEPTABLE TO THE RECEIVING LAW ENFORCEMENT UNIT, BY THE END OF EACH BUSINESS DAY. Each copy of a record, submitted to the primary law enforcement unit and, 10 (c) 11 if applicable, local law enforcement unit, shall include: 12 (1) the license number of the dealer; 13 (2) the location of each item listed in the record; and 14 (3) the information required under § 12-302 of this subtitle. 15 A copy of a record submitted under this section: (d) shall be kept confidential; 16 (1) 17 (2) is not a public record; and is not subject to Title 10, Subtitle 6 of the State Government Article. 18 (3) 19 A law enforcement unit may destroy the copy of a record submitted under 20 this section after 1 year from the date the law enforcement unit receives the copy. 21 SECTION 2.
