A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws - "Fear the Turtle!" Scholarship Registration Plates**

3 FOR the purpose of requiring the Motor Vehicle Administration to develop and make
4 available a specially designed registration plate honoring the diamondback
5 terrapin, the State reptile and mascot of the University of Maryland, College
6 Park, and to support certain student scholarships at the University of
7 Maryland, College Park; prescribing who may apply for and the classes of
8 vehicles eligible for the registration plate; providing the manner in which fees
9 will be established, collected, and distributed in connection with the registration
10 plate; requiring the Administration to consult with the University of Maryland,
11 College Park on certain matters concerning the design of the registration plate
12 and the collection and distribution of fees associated with the plate; providing a
13 certain fee exemption applicable to disabled veterans; requiring the
14 Administration to adopt certain regulations; and generally relating to the
15 issuance of a special registration plate honoring the diamondback terrapin and
16 supporting certain student scholarships at the University of Maryland, College
17 Park.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
24 MARYLAND, That the Laws of Maryland read as follows:

25 **Article - Transportation**

26 13-619.3.

27 (A) IN CONSULTATION WITH THE UNIVERSITY OF MARYLAND, COLLEGE
28 PARK, THE ADMINISTRATION SHALL DEVELOP AND MAKE AVAILABLE FOR
29 QUALIFYING VEHICLES A SPECIALLY DESIGNED REGISTRATION PLATE HONORING
30 THE DIAMONDBACK TERRAPIN (MALACLEMYS TERRAPIN), THE STATE REPTILE AND

1 OFFICIAL MASCOT OF THE STATE'S FLAGSHIP UNIVERSITY AT COLLEGE PARK, FOR
2 THE PURPOSE OF PROVIDING REVENUE TO SUPPORT STUDENT SCHOLARSHIPS AT
3 THE UNIVERSITY OF MARYLAND, COLLEGE PARK AS SPECIFIED IN SUBSECTION (E)
4 OF THIS SECTION.

5 (B) THE OWNER OF A VEHICLE, OR A LESSEE OF THE VEHICLE UNDER A
6 LEASE NOT INTENDED AS SECURITY, OR A DIRECTOR, OFFICER, EMPLOYEE, OR
7 PARTNER OF A BUSINESS ENTITY THAT OWNS THE VEHICLE CONSIDERED ELIGIBLE
8 BY THE ADMINISTRATION MAY APPLY TO THE ADMINISTRATION FOR AN ORIGINAL
9 OR SUBSTITUTE REGISTRATION PLATE UNDER THIS SECTION IF THE VEHICLE IS
10 INCLUDED IN ONE OF THE FOLLOWING CLASSES:

11 (1) A CLASS A (PASSENGER) VEHICLE;

12 (2) A CLASS B (FOR HIRE) VEHICLE;

13 (3) A CLASS E (TRUCK) VEHICLE WITH A MANUFACTURER'S RATED
14 CAPACITY OF ONE TON OR LESS;

15 (4) A CLASS E (FARM TRUCK) VEHICLE;

16 (5) A CLASS G (TRAILER) VEHICLE; OR

17 (6) A CLASS M (MULTIPURPOSE) VEHICLE.

18 (C) (1) IN ADDITION TO THE ANNUAL REGISTRATION FEE OTHERWISE
19 REQUIRED UNDER THIS TITLE, AN OWNER OF A VEHICLE ASSIGNED A REGISTRATION
20 PLATE UNDER THIS SECTION SHALL PAY:

21 (I) WHEN INITIALLY ISSUED THE REGISTRATION PLATE, A
22 ONE-TIME FEE SET BY THE ADMINISTRATION TO RECOVER THE ADMINISTRATION'S
23 COSTS UNDER THIS SECTION; AND

24 (II) WHEN INITIALLY ISSUED THE REGISTRATION PLATE, AND
25 EACH TIME THE REGISTRATION PLATE IS RENEWED, AN ADDITIONAL FEE SET BY
26 THE ADMINISTRATION TO BENEFIT THE UNIVERSITY OF MARYLAND, COLLEGE PARK
27 FOR USE FOR STUDENT SCHOLARSHIPS.

28 (2) THE ADDITIONAL FEE COLLECTED UNDER THIS SECTION IS NOT
29 REQUIRED FOR SPECIAL REGISTRATION OF A VEHICLE THAT IS EXEMPT UNDER §
30 13-903 OF THIS TITLE.

31 (3) NO PORTION OF THE FEE COLLECTED UNDER THIS SECTION MAY BE
32 CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR
33 DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.

34 (D) THE ADMINISTRATION SHALL CONSULT WITH THE UNIVERSITY OF
35 MARYLAND, COLLEGE PARK ON:

1 (1) THE DESIGN OF THE REGISTRATION PLATE TO BE ISSUED UNDER
2 THIS SECTION, WHICH SHALL:

3 (I) DEPICT THE DIAMONDBACK TERRAPIN, THE MASCOT OF THE
4 UNIVERSITY OF MARYLAND, COLLEGE PARK; AND

5 (II) INCLUDE THE WORDS "FEAR THE TURTLE!";

6 (2) THE SETTING OF THE FEE TO BE CHARGED UNDER SUBSECTION
7 (C)(1)(II) OF THIS SECTION AT A LEVEL INTENDED TO ENCOURAGE THE PURCHASE OF
8 THE REGISTRATION PLATE ISSUED UNDER THIS SECTION WHILE PROVIDING A
9 CONTINUOUS REVENUE SOURCE TO SUPPORT STUDENT SCHOLARSHIPS AT THE
10 UNIVERSITY OF MARYLAND, COLLEGE PARK; AND

11 (3) A SCHEDULE UNDER WHICH THE ADMINISTRATION WILL TRANSFER
12 TO THE UNIVERSITY OF MARYLAND, COLLEGE PARK REVENUE COLLECTED ON THE
13 UNIVERSITY'S BEHALF TO SUPPORT STUDENT SCHOLARSHIPS.

14 (E) THE UNIVERSITY OF MARYLAND, COLLEGE PARK SHALL USE THE
15 REVENUE IT RECEIVES UNDER THIS SECTION AS FOLLOWS:

16 (1) ONE-HALF TO SUPPORT SCHOLARSHIPS FOR STUDENT ATHLETES;
17 AND

18 (2) ONE-HALF TO SUPPORT SCHOLARSHIPS FOR MARYLAND RESIDENTS
19 WHO ARE MAJORING IN ENVIRONMENTAL OR BIOLOGICAL SCIENCE.

20 (F) THE ADMINISTRATION SHALL ADOPT REGULATIONS TO GOVERN THE
21 ISSUANCE OF SPECIAL REGISTRATION PLATES UNDER THIS SECTION.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2004.
