## 2 Vehicle Laws - Registration Plates Honoring Mountain Maryland

- 3 FOR the purpose of requiring the Motor Vehicle Administration to develop and make
- 4 available a specially designed registration plate honoring Mountain Maryland;
- 5 specifying the vehicles that are eligible for the registration plate; requiring the
- 6 owner of a vehicle issued the registration plate to pay certain fees; providing for
- 7 the distribution of a certain fee; requiring the Administration to consult with the
- 8 Greater Allegany Business Foundation and the Garrett County Economic
- 9 Development Corporation on certain matters; requiring the Administration to
- adopt regulations; and generally relating to registration plates honoring
- 11 Mountain Maryland.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:

- 21 (A) IN CONSULTATION WITH THE GREATER ALLEGANY BUSINESS
- 22 FOUNDATION AND THE GARRETT COUNTY ECONOMIC DEVELOPMENT
- 23 CORPORATION, THE ADMINISTRATION SHALL DEVELOP AND MAKE AVAILABLE FOR
- 24 QUALIFYING VEHICLES A SPECIALLY DESIGNED REGISTRATION PLATE HONORING
- 25 THE STATEWIDE SIGNIFICANCE AND CONTRIBUTIONS OF MOUNTAIN MARYLAND,
- 26 COMPRISING ALLEGANY AND GARRETT COUNTIES.
- 27 (B) THE OWNER OF A VEHICLE, OR A LESSEE OF THE VEHICLE UNDER A
- 28 LEASE NOT INTENDED AS SECURITY, OR A DIRECTOR, OFFICER, EMPLOYEE, OR
- 29 PARTNER OF A BUSINESS ENTITY THAT OWNS THE VEHICLE CONSIDERED ELIGIBLE

- 1 BY THE ADMINISTRATION MAY APPLY TO THE ADMINISTRATION FOR AN ORIGINAL
- 2 OR SUBSTITUTE REGISTRATION PLATE UNDER THIS SECTION IF THE VEHICLE IS

- 10 (6) A CLASS M (MULTIPURPOSE) VEHICLE.
- 11 (C) (1) IN ADDITION TO THE ANNUAL REGISTRATION FEE OTHERWISE
- 12 REQUIRED UNDER THIS TITLE, AN OWNER OF A VEHICLE ASSIGNED A REGISTRATION
- 13 PLATE UNDER THIS SECTION SHALL PAY:
- 14 (I) WHEN INITIALLY ISSUED THE REGISTRATION PLATE. A
- 15 ONE-TIME FEE SET BY THE ADMINISTRATION TO RECOVER THE ADMINISTRATION'S
- 16 COSTS UNDER THIS SECTION; AND
- 17 (II) WHEN INITIALLY ISSUED THE REGISTRATION PLATE, AND

- 25 (3) NO PORTION OF THE FEE COLLECTED UNDER THIS SECTION MAY BE
- 26 CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR
- 27 DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.
- 28 (D) THE ADDITIONAL FEE COLLECTED UNDER THIS SECTION SHALL BE
- 29 DISTRIBUTED:
- 30 (1) IF THE OWNER OF THE VEHICLE IS A RESIDENT OF ALLEGANY
- 31 COUNTY, TO THE GREATER ALLEGANY BUSINESS FOUNDATION:
- 32 (2) IF THE OWNER OF THE VEHICLE IS A RESIDENT OF GARRETT
- 33 COUNTY, TO THE GARRETT COUNTY ECONOMIC DEVELOPMENT CORPORATION; AND
- 34 (3) IF THE OWNER OF THE VEHICLE IS NOT A RESIDENT OF GARRETT
- 35 COUNTY OR ALLEGANY COUNTY, IN EQUAL PORTIONS, TO THE GREATER ALLEGANY

- 9 (2) THE SETTING OF THE FEE TO BE CHARGED UNDER SUBSECTION
