4 FC 5 6 7 8 9 10 11 12 13 14	OR the purpose of authorizing the Baltimore County Board of License Commissioners to transfer a certain number of beer, wine and liquor (on-sale) retail alcoholic beverages licenses in existence in Election District 15 into the Hunt Valley Commercial/Mixed Use Focal Point; requiring the licenses to be converted into Class B (HV) restaurant beer, wine and liquor licenses; providing for certain restrictions, qualifications, and conditions with respect to the licenses and the establishments subject to the licenses, including hours of operation, percentage of receipts from the sale of food, seating capacity, zoning regulations, and other requirements; prohibiting the transfer of a license issued under this Act to a new location other than the original location; prohibiting the issuance of more than a total of a certain number of beer, wine and liquor

- 6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 7 MARYLAND, That the Laws of Maryland read as follows:
- 8 Article 2B Alcoholic Beverages
- 9 8-204.4.
- 10 (A) THIS SECTION APPLIES ONLY IN BALTIMORE COUNTY.
- 11 (B)(1) NOTWITHSTANDING THE LICENSE POPULATION QUOTA LIMITATIONS AND
- 12 IN ADDITION TO THE LICENSES AUTHORIZED FOR ISSUANCE UNDER THIS ARTICLE,
- 13 THE BOARD OF LICENSE COMMISSIONERS MAY AUTHORIZE THE TRANSFER OF TWO
- 14 BEER, WINE AND LIQUOR (ON-SALE) RETAIL LICENSES IN EXISTENCE IN ELECTION
- 15 DISTRICT 15 ON JULY 1, 2004, AND VALID ON THE DATE OF TRANSFER INTO THE
- 16 "HUNT VALLEY COMMERCIAL/MIXED USE FOCAL POINT" AS DESIGNATED IN THE
- 17 HUNT VALLEY/TIMONIUM MASTER PLAN, ADOPTED BY THE BALTIMORE COUNTY

- 19 (2) A LICENSE TRANSFERRED UNDER THIS SECTION:
- 20 (I) MAY NOT BE A CLASS A OR C LICENSE OR A LICENSE THAT IS
- 21 PROHIBITED FROM BEING TRANSFERRED BY LAW OR LOCAL REGULATION OTHER
- 22 THAN CROSSING DISTRICT LINES;
- 23 (II) SHALL BE CONSIDERED A REGULAR LICENSE AND NOT AN
- 24 EXCEPTION LICENSE FOR PURPOSES OF DETERMINING THE TOTAL NUMBER OF
- 25 LICENSES AVAILABLE IN ANY ELECTION DISTRICT BASED ON THE RULE OF THE
- 26 BOARD OF LICENSE COMMISSIONERS THAT LIMITS THE TOTAL NUMBER OF
- 27 LICENSES AVAILABLE BY POPULATION;
- 28 (III) SHALL BE CONVERTED INTO A CLASS B (HV) LICENSE; AND

- 31 (C) SUBJECT TO THE PROVISIONS OF SUBSECTION (D) OF THIS SECTION, THE
- 32 RESTRICTIONS AND QUALIFICATIONS FOR THE ISSUANCE AND FEE OF THE CLASS B
- 33 (HV) RESTAURANT (ON-SALE) BEER, WINE AND LIQUOR RETAIL LICENSE UNDER THIS
- 34 SECTION, THE MINIMUM SQUARE FOOT AREA REQUIREMENT FOR FOOD AND
- 35 BEVERAGE PREPARATION AND CONSUMPTION IN THE LICENSED ESTABLISHMENT,
- 36 AND THE DAYS AND HOURS OF SALE FOR THE LICENSED ESTABLISHMENT SHALL BE

- 3 (D) THE FOLLOWING ADDITIONAL REQUIREMENTS APPLY TO THE CLASS B
- 4 (HV) RESTAURANT (ON-SALE) BEER, WINE AND LIQUOR RETAIL LICENSE
- 5 ESTABLISHED BY THIS SECTION:
- 6 (1) THE LICENSE MAY BE ISSUED ONLY FOR A LOCATION WITHIN THE
- 7 "HUNT VALLEY COMMERCIAL/MIXED USE FOCAL POINT" AS DESIGNATED IN THE
- 8 HUNT VALLEY/TIMONIUM MASTER PLAN, ADOPTED BY THE BALTIMORE COUNTY
- 9 COUNCIL ON OCTOBER 19, 1998;
- 10 (2) THE LICENSE SHALL BE USED IN CONJUNCTION WITH THE
- 11 OPERATION OF A RESTAURANT, AS DEFINED IN THIS ARTICLE AND THE
- 12 REGULATIONS OF THE BOARD OF LICENSE COMMISSIONERS;
- 13 (3) THE RESTAURANT OPERATION SHALL MAINTAIN AVERAGE DAILY
- 14 RECEIPTS FROM THE SALE OF THE FOOD OF AT LEAST 70% OF THE TOTAL DAILY
- 15 RECEIPTS OF THE ESTABLISHMENT;
- 16 (4) THE TOTAL SEATING CAPACITY FOR THE AREA DEDICATED
- 17 PRIMARILY FOR THE PURPOSE OF THE CONSUMPTION OF ALCOHOLIC BEVERAGES
- 18 MAY NOT EXCEED 25% OF THE TOTAL SEATING CAPACITY OF THE ESTABLISHMENT;
- 19 AND
- 20 (5) SUBJECT TO THE PROVISIONS OF SUBSECTION (H) OF THIS SECTION,
- 21 THE HOURS DURING WHICH THE PRIVILEGES CONFERRED BY THE LICENSE MAY BE
- 22 EXERCISED MAY NOT EXCEED THE HOURS FOR WHICH FOOD IS OFFERED FOR SALE.
- 23 (E) THE LICENSE AUTHORIZES ON-PREMISES SALES ONLY.
- 24 (F) THE PROPOSED PREMISES SHALL COMPLY WITH ALL APPLICABLE ZONING 25 REGULATIONS.
- 26 (G) (1) ONCE ISSUED, THE LICENSE MAY NOT BE:
- 27 (I) TRANSFERRED TO A NEW LOCATION OTHER THAN THE
- 28 ORIGINAL LOCATION FOR WHICH THE LICENSE WAS ISSUED; OR
- 29 (II) CONVERTED INTO ANY OTHER CLASS OF LICENSE.
- 30 (2) HOWEVER, PARAGRAPH (1) OF THIS SUBSECTION DOES NOT
- 31 PROHIBIT THE TRANSFER OF OWNERSHIP OF THE LICENSE TO BE TRANSFERRED.
- 32 (H) ALCOHOLIC BEVERAGES MAY BE SOLD IN THE ESTABLISHMENT ONLY
- 33 UNTIL 1:30 A.M.
- 34 (I) THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE MORE THAN A
- 35 TOTAL OF THREE 3 BEER, WINE AND LIQUOR LICENSES IN THE HUNT VALLEY
- 36 COMMERCIAL/MIXED USE FOCAL POINT UNDER THE EXCEPTIONS IN RULE 19 OF THE

- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
