SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 MARYLAND, That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

- 3 (A) THIS SECTION APPLIES ONLY IN BALTIMORE COUNTY.
- 4 (B)(1) NOTWITHSTANDING THE LICENSE POPULATION QUOTA LIMITATIONS AND
- 5 IN ADDITION TO THE LICENSES AUTHORIZED FOR ISSUANCE UNDER THIS ARTICLE,
- 6 THE BOARD OF LICENSE COMMISSIONERS MAY AUTHORIZE THE TRANSFER OF TWO
- 7 BEER, WINE AND LIQUOR (ON-SALE) RETAIL LICENSES IN EXISTENCE IN ELECTION
- 8 DISTRICT 15 ON JULY 1, 2004, AND VALID ON THE DATE OF TRANSFER INTO THE

- 12 (2) A LICENSE TRANSFERRED UNDER THIS SECTION:
- 13 (I) MAY NOT BE A CLASS A OR C LICENSE OR A LICENSE THAT IS
- 14 PROHIBITED FROM BEING TRANSFERRED BY LAW OR LOCAL REGULATION OTHER
- 15 THAN CROSSING DISTRICT LINES;
- 16 (II) SHALL BE CONSIDERED A REGULAR LICENSE AND NOT AN
- 17 EXCEPTION LICENSE FOR PURPOSES OF DETERMINING THE TOTAL NUMBER OF
- 18 LICENSES AVAILABLE IN ANY ELECTION DISTRICT BASED ON THE RULE OF THE

- 37 (1) THE LICENSE MAY BE ISSUED ONLY FOR A LOCATION WITHIN THE
- 38 "HUNT VALLEY COMMERCIAL/MIXED USE FOCAL POINT" AS DESIGNATED IN THE

- 1 HUNT VALLEY/TIMONIUM MASTER PLAN, ADOPTED BY THE BALTIMORE COUNTY 2 COUNCIL ON OCTOBER 19, 1998;
- 3 (2) THE LICENSE SHALL BE USED IN CONJUNCTION WITH THE
- 4 OPERATION OF A RESTAURANT, AS DEFINED IN THIS ARTICLE AND THE
- 5 REGULATIONS OF THE BOARD OF LICENSE COMMISSIONERS;
- 6 (3) THE RESTAURANT OPERATION SHALL MAINTAIN AVERAGE DAILY
- 7 RECEIPTS FROM THE SALE OF THE FOOD OF AT LEAST 70% OF THE TOTAL DAILY
- 8 RECEIPTS OF THE ESTABLISHMENT:
- 9 (4) THE TOTAL SEATING CAPACITY FOR THE AREA DEDICATED

- 13 (5) SUBJECT TO THE PROVISIONS OF SUBSECTION (H) OF THIS SECTION,
- 14 THE HOURS DURING WHICH THE PRIVILEGES CONFERRED BY THE LICENSE MAY BE
- 15 EXERCISED MAY NOT EXCEED THE HOURS FOR WHICH FOOD IS OFFERED FOR SALE.
- 16 (E) THE LICENSE AUTHORIZES ON-PREMISES SALES ONLY.
- 17 (F) THE PROPOSED PREMISES SHALL COMPLY WITH ALL APPLICABLE ZONING 18 REGULATIONS.
- 19 (G) (1) ONCE ISSUED, THE LICENSE MAY NOT BE:
- 20 (I) TRANSFERRED TO A NEW LOCATION OTHER THAN THE
- 21 ORIGINAL LOCATION FOR WHICH THE LICENSE WAS ISSUED; OR
- 22 (II) CONVERTED INTO ANY OTHER CLASS OF LICENSE.
- 23 (2) HOWEVER, PARAGRAPH (1) OF THIS SUBSECTION DOES NOT
- 24 PROHIBIT THE OWNERSHIP OF THE LICENSE TO BE TRANSFERRED.
- 25 (H) ALCOHOLIC BEVERAGES MAY BE SOLD IN THE ESTABLISHMENT ONLY

- 27 (I) THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE MORE THAN A
- 28 TOTAL OF THREE BEER, WINE AND LIQUOR LICENSES IN THE HUNT VALLEY
- 29 COMMERCIAL/MIXED USE FOCAL POINT UNDER THE EXCEPTIONS IN RULE 19 OF THE
- 30 RULES AND REGULATIONS OF THE BALTIMORE COUNTY BOARD OF LICENSE
