- 4 FOR the purpose of authorizing municipal corporations to create within their
- 5 corporate limits special taxing districts for the purpose of financing certain
- 6 capital and operating costs to enhance police and fire protection; authorizing
- 7 municipal corporations to fix, impose, and collect certain taxes and issue bonds
- 8 or other obligations for certain purposes; and generally relating to authorizing
- 9 municipal corporations to create special taxing districts to enhance police and

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

- 20 (a) Pursuant to the provisions of § 5 of Article XI-E of the Constitution of
- 21 Maryland prohibiting any municipal corporation classified by the General Assembly
- 22 under the provisions of § 2 of Article XI-E of the Constitution of Maryland from
- 23 levying any type of tax, license fee, franchise tax or fee which was not in effect in the
- 24 municipal corporation on January 1, 1954, unless it has received the express
- 25 authorization of the General Assembly for that purpose, by a general law which in its
- 26 terms and its effect applies alike to all similarly classified municipal corporations, the
- 27 General Assembly hereby expressly authorizes all municipal corporations in this
- 28 State within the class created by § 10 of this article for the purpose of financing the
- 29 design, construction, establishment, extension, alteration or acquisition of adequate

- 1 storm drainage systems, for the purpose of financing the design, acquisition,
- 2 establishment, improvement, extension, operation or alteration of public parking
- 3 facilities, or pedestrian malls, for the purpose of financing the design, acquisition,
- 4 erection, construction, improvement and maintenance of street and area lighting, FOR
- 5 THE PURPOSE OF FINANCING THE CAPITAL AND OPERATING COSTS TO ENHANCE
- 6 POLICE AND FIRE PROTECTION, and for the purposes set forth in § 2(b)(35) of this
- 7 article, to create within their respective corporate limits special taxing districts for
- 8 these purposes and to levy on all real and personal property located within these
- 9 special taxing districts and ad valorem tax at a rate sufficient to provide adequate
- 10 annual revenues to pay the principal and interest on any bonds or other obligations of
- 11 the municipality issued for these purposes as the principal and interest become due,
- 12 and to pay the costs of operating and maintaining these facilities and activities. These
- 13 taxes shall be levied in the same manner, upon the same assessments, for the same
- 14 period or periods, and as of the same date or dates of finality as are now or may
- 15 hereafter be prescribed.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2004.
