- 5 FOR the purpose of providing that members of the Howard County Board of
- 6 Education may participate, under certain terms and conditions, in health
- 7 insurance and other benefit programs sponsored by the Board; prohibiting
- 8 certain retirement contributions and certain other benefits in which a Board
- 9 member participates from being calculated as certain compensation for the
- members of the Howard County Board of Education; providing that this Act does
- 11 not apply to the compensation of the incumbent members of the Howard County

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

## 21 Article - Education

- 22 3-703.
- 23 (a) The Chairman of the County Board is entitled to receive \$14,000 annually
- 24 as compensation and the other members are entitled to receive \$12,000 each annually
- 25 as compensation.
- 26 (b) The Chairman and the other members are entitled to the allowances for
- 27 travel and other expenses provided in the Howard County budget.

- 1 (C) THE EMPLOYER'S SHARE FOR STATE RETIREMENT AND PENSION
- 2 CONTRIBUTIONS MADE ON BEHALF OF THE CHAIRMAN AND OTHER BOARD
- 3 MEMBERS MAY NOT BE CONSIDERED COMPENSATION FOR THE PURPOSE OF
- 4 CALCULATING COMPENSATION UNDER SUBSECTION (A) OF THIS SECTION.
- 5 (D) (1) THE CHAIRMAN AND OTHER BOARD MEMBERS MAY PARTICIPATE IN 6 HEALTH INSURANCE AND OTHER BENEFIT PROGRAMS SPONSORED BY THE BOARD.
- 7 (2) A BOARD MEMBER'S PARTICIPATION IN A BENEFIT PROGRAM
- 8 SPONSORED BY THE BOARD UNDER THIS SUBSECTION MAY NOT BE CONSIDERED
- 9 COMPENSATION FOR THE PURPOSE OF CALCULATING COMPENSATION UNDER
- 10 SUBSECTION (A) OF THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
- 12 § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
- 13 the salary or compensation of the Howard County Board of Education members in
- 14 office on the effective date of this Act, but the provisions of this Act concerning the
- 15 salary or compensation of the Howard County Board of Education members shall take
- 16 effect at the beginning of the next following term of office.
- 17 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take 18 effect October 1, 2004.
