10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That the Laws of Maryland read as follows:

Article - Election Law

13 3-303.

(a) Except as provided in [subsections] SUBSECTION (b) [and (c)] of this
section, a local board, at the signed request of a registered voter, shall change that
voter's party affiliation, or change the voter to or from a decline, at any time that
registration is open.

18 (b) (1) Except as provided in paragraph (2) of this subsection, party 19 affiliation may not be changed:

20 (i) from 9 p.m. on the [Monday, or the next regular business day if 21 the Monday is a legal holiday, that is 12 weeks before the day on which a primary

22 election is to be held under § 8-201 of this article,] 21ST DAY PRECEDING THE

23 PRIMARY ELECTION until and including the day on which the registration reopens

24 after the primary election is held; and

25 (ii) from and including the day of issuance of a gubernatorial

26 proclamation calling a special election, pursuant to § 8-710 of this article, or from 5

27 p.m. on the next regular business day if the day of issuance is a legal holiday, until

28 and including the day on which that special election is held.

1 (2) If a voter requests a party affiliation change during a period specified 2 in paragraph (1) of this subsection, the local board shall make the change if:

3 (i) there is sufficient evidence, as determined by the local boards
4 pursuant to regulations adopted by the State Board, that the request was mailed
5 before the beginning of the period specified in paragraph (1) of this subsection; or

6 (ii) the request was submitted by the voter to the Motor Vehicle 7 Administration, a voter registration agency, another local board, or the State Board 8 before the beginning of the period specified in paragraph (1) of this subsection.

9 (c) [If a registered voter has moved from one county to another within the 10 State since the last general election, the voter may change party affiliation or change 11 to or from a decline, one time only, during a period specified in subsection (b)(1) of this 12 section.

(d)] An individual whose registration has been canceled at the individual's
request within a period specified in subsection (b) of this section may not reregister in
the same county during the same period with a party affiliation or nonaffiliation
different from the previous registration.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2004.
