- 3 FOR the purpose of establishing the Young Farmers Advisory Board; specifying the
- 4 membership, terms of membership, and duties of the Advisory Board; requiring

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:
- 22 Article Agriculture
- 23 SUBTITLE 10. YOUNG FARMERS ADVISORY BOARD.
- 24 2-1001.
- 25 THERE IS A YOUNG FARMERS ADVISORY BOARD IN THE DEPARTMENT.

- 1 2-1002.
- 2 (A) THE YOUNG FARMERS ADVISORY BOARD SHALL CONSIST OF 12 MEMBERS 3 APPOINTED BY THE GOVERNOR.
- 4 (B) OF THE 12 MEMBERS:
- 5 (1) ONE SHALL BE FROM THE DEPARTMENT OF AGRICULTURE;
- 6 (2) ONE SHALL BE FROM THE DEPARTMENT OF BUSINESS AND 7 ECONOMIC DEVELOPMENT:
- 8 (3) ONE SHALL BE FROM THE FORESTRY PROGRAM WITHIN THE 9 DEPARTMENT OF NATURAL RESOURCES;
- 10 (4) ONE SHALL BE FROM THE FARM BUREAU; AND
- 11 (5) EIGHT SHALL BE APPOINTED FROM THE GENERAL PUBLIC.
- 12 (C) TO THE EXTENT PRACTICABLE, THE GOVERNOR SHALL ATTEMPT TO
- 13 ENSURE REGIONAL DIVERSITY AMONG THE MEMBERS OF THE ADVISORY BOARD
- 14 APPOINTED FROM THE GENERAL PUBLIC.
- 15 (D) EACH MEMBER FROM THE GENERAL PUBLIC SHALL:
- 16 (1) BE INTERESTED IN THE PRESERVATION AND DEVELOPMENT OF
- 17 AGRICULTURE AND PRESERVATION OF THE AGRICULTURAL WAY OF LIFE IN
- 18 MARYLAND;
- 19 (2) BE UNDER THE AGE OF 45 YEARS AT THE BEGINNING OF A MEMBER'S 20 TERM;
- 21 (3) DERIVE AT LEAST 50% OF THE MEMBER'S PERSONAL INCOME FROM
- 22 FARMING OR AGRICULTURAL ACTIVITIES IN THE STATE; AND
- 23 (4) BE A RESIDENT OF THE STATE.
- 24 (E) (1) EXCEPT FOR THE INITIAL TERMS OF THE ADVISORY BOARD, THE
- 25 TERM OF A MEMBER SHALL BE 3 YEARS.
- 26 (2) (I) THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY
- 27 THE TERMS PROVIDED FOR MEMBERS OF THE ADVISORY BOARD ON OCTOBER 1, 2004.
- 28 (II) THE TERMS OF THE INITIAL MEMBERS SHALL BE STAGGERED
- 29 EVENLY BETWEEN 2 YEARS AND 3 YEARS AS THE ADVISORY BOARD SHALL
- 30 DETERMINE AT THE BOARD'S FIRST MEETING.

- 2 THE ADVISORY BOARD SHALL:
- 3 (1) ANNUALLY ELECT FROM ITS MEMBERS A CHAIRPERSON, A VICE
- 4 CHAIRPERSON, AND A SECRETARY OF THE ADVISORY BOARD AT THE ADVISORY
- 5 BOARD'S FIRST MEETING OF THE CALENDAR YEAR;
- 6 (2) COMMUNICATE TO THE GENERAL PUBLIC, THE FEDERAL
- 7 GOVERNMENT, THE STATE GOVERNMENT, AND MARYLAND AGRICULTURAL
- 8 COMMISSION THE IMPORTANCE OF YOUNG AND BEGINNING FARMERS TO
- 9 AGRICULTURE IN THE STATE:
- 10 (3) IDENTIFY AND ADDRESS ISSUES RELATING TO YOUNG AND
- 11 BEGINNING FARMERS IN THE STATE AND MAKE RECOMMENDATIONS TO THE

- 13 (4) ESTABLISH COMMITTEES, AS NECESSARY, TO DEVELOP PROJECTS
- 14 RELATING TO THE ASPECTS OF LIFE FOR YOUNG AND BEGINNING FARMERS IN THE

- 16 (5) HOLD MEETINGS AT LEAST ONCE DURING EACH CALENDAR

- 18 (6) ADOPT A MISSION STATEMENT AND ADMINISTRATIVE PROCEDURES
- 19 TO IMPLEMENT THIS SUBTITLE.

- 21 (A) A MEMBER OF THE ADVISORY BOARD:
- 22 (1) MAY NOT RECEIVE COMPENSATION; BUT
- 23 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
- 24 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.
- 25 (B) THE DEPARTMENT SHALL PROVIDE STAFF FOR THE ADVISORY BOARD.
- 26 2-1005.
- 27 THE CHAIRPERSON, OR THE CHAIRPERSON'S DESIGNEE, SHALL:
- 28 (1) ATTEND MEETINGS OF THE MARYLAND AGRICULTURAL
- 29 COMMISSION: AND
- 30 (2) PROVIDE A QUARTERLY REPORT TO THE MARYLAND AGRICULTURAL
- 31 COMMISSION.
- 32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 33 effect October 1, 2004. It shall remain effective for a period of 3 years and, at the end

- of September 30, 2007, with no further action required by the General Assembly, this
 Act shall be abrogated and of no further force and effect.
