

- 22 of the county in which the place of business is located. The holder of the license may
- 23 keep for sale and sell beer at retail at the place described in the license. The beer may
- 24 be consumed on the premises or elsewhere, but a license may not be issued for any
- 25 drugstore.
- 26 (j) In Charles County the annual license fee is [\$150] \$180.
