18 (A) IN A CIVIL ACTION THAT RESULTS IN A JURY VERDICT FOR MONETARY
19 DAMAGES IN FAVOR OF A PLAINTIFF, A COURT MAY ORDER A NEW TRIAL ON THE
20 ISSUE OF DAMAGES, OR ON THE ISSUES OF DAMAGES AND LIABILITY, IF:

21 (1) THE COURT DETERMINES THAT THE VERDICT IS EXCESSIVE OR 22 INADEQUATE; AND

23 (2) THE PARTIES DO NOT AGREE TO A DECREASE OR INCREASE OF THE
24 AMOUNT OF DAMAGES AWARDED BY THE JURY TO A REASONABLE AMOUNT
25 DETERMINED BY THE COURT.
