BE IT ENACTED BY THE GENERAL ASSEMBLY OF 6 MARYLAND, That: 7 There is a Task Force to Study the Dynamics of Elderly and Retiree (a) 8 Migration Into and Out of Maryland. 9 (b) The Task Force shall be composed of 16 17 18 members as follows: 10 (1) one member of the Senate of Maryland, appointed by the President of 11 the Senate; 12 (2) one member of the House of Delegates, appointed by the Speaker of 13 the House; 14 (3) the Secretary of Aging, or the Secretary's designee; 15 (4) the Secretary of Business and Economic Development, or the 16 Secretary's designee; 17 (5) the Secretary of Planning, or the Secretary's designee; 18 (6) the Executive Director of the Forvm for Rural Maryland Council, or 19 the Executive Director's designee; 20 (7) one representative from the Maryland Association of Counties, 21 appointed by the Governor; 22 one representative from a Maryland chapter of the National 23 Association of Retired Federal Employees, appointed by the Governor; 24 one representative of AARP, formerly known as the American 25 Association of Retired Persons, appointed by the Governor; one representative of the Maryland Gerontology Gerontological 26 (10)27 Association, appointed by the Governor; 28 one representative of the health care industry with expertise in (11)29 senior health issues, appointed by the Governor; 30 (12)one representative of the housing industry with expertise in senior 31 housing and retirement community issues, appointed by the Governor;

	(e) A member of the Task Force may not receive compensation for serving on the Task Force, but is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.
20	(f) (1) The Task Force shall oversee and assist in preparing a comprehensive and objective study to be conducted by the Maryland Institute for Governmental Service, the Maryland Institute for Policy Analysis and Research, Loyola College in Maryland, and the Regional Economic Studies Institute.
22	(2) The study shall:
23 24	(i) review the dynamics of elderly and retiree migration into and out of the State;
25 26	(ii) assess the impact, if any, that the tax policies and benefits of the State and other states have on elderly and retiree migration, including:
27 28	1. a comparison of the total tax burden in the State on the elderly and retirees as compared to other states; and
29 30	2. a comparison of the total tax burden in the State on the elderly and retirees as a percentage of personal income as compared to other states;
	(iii) examine the benefits that the elderly and retirees provide to the local community and the State by participating in mentoring or volunteer programs or similar community activities; and
34 35	(iv) examine State <u>and county</u> expenditures on the elderly and retirees including health care expenditures.

- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 June 1, 2004.
