## 1 AN ACT concerning

## **Education - Elementary and Secondary Schools - Parental Involvement Plans**

4 FOR the purpose of requiring each local school district and each school to develop and  
5 implement a certain parental involvement plan on or before a certain date;  
6 establishing the requirements for each plan; requiring each school to prepare  
7 certain parental involvement family kits; establishing the components of each  
8 kit; requiring each school to hold a certain meeting at the beginning of each  
9 school year; requiring that parents be given certain materials and certain  
10 information at a certain meeting; requiring each local school district to develop  
11 and implement a parental involvement grading system; providing for the  
12 requirements of the grading system; requiring each school to publish a volunteer  
13 resource book based on the results of a certain parent survey; providing for the  
14 requirements of the volunteer resource book; requiring the principal of each  
15 school to designate a certain staff member as a parent facilitator; requiring the  
16 parent facilitator to organize certain staff training; requiring the State Board of  
17 Education to require at least a certain number of hours of parental involvement  
18 staff training as professional development each year; and generally relating to  
19 the development of parental involvement plans in elementary and secondary  
20 schools.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
27 MARYLAND, That the Laws of Maryland read as follows:

## 1 Article - Education

2 7-115.

3 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
4 INDICATED.

5 (2) "KIT" MEANS THE PARENTAL INVOLVEMENT FAMILY KIT.

6 (3) "PARENT" INCLUDES A STUDENT'S LEGAL GUARDIAN OR RELATIVE.

7 (4) "PLAN" MEANS THE PARENTAL INVOLVEMENT PLAN DEVELOPED BY  
8 A LOCAL SCHOOL DISTRICT OR A SCHOOL UNDER THIS SECTION.9 (B) (1) ON OR BEFORE SEPTEMBER 1, 2004, EACH LOCAL SCHOOL DISTRICT  
10 AND EACH SCHOOL, IN COLLABORATION WITH THE PARENTS OF ITS STUDENTS,  
11 SHALL DEVELOP AND IMPLEMENT A PARENTAL INVOLVEMENT PLAN.12 (2) THE PURPOSE OF THE PLAN IS TO ESTABLISH PROGRAMS AND  
13 PRACTICES THAT ENHANCE PARENTAL INVOLVEMENT IN THEIR CHILDREN'S  
14 EDUCATION AND REFLECT THE SPECIFIC NEEDS OF THE CHILDREN AS STUDENTS  
15 AND THE NEEDS OF THE STUDENTS' FAMILIES.

16 (3) EACH PLAN SHALL:

17 (I) APPLY TO PARENTS OF STUDENTS AT ALL GRADE LEVELS IN A  
18 VARIETY OF ROLES;19 (II) RECOGNIZE THAT COMMUNICATION BETWEEN PARENTS AND  
20 SCHOOLS SHOULD BE REGULAR, TWO-WAY, AND MEANINGFUL TO BE EFFECTIVE;

21 (III) PROMOTE AND SUPPORT RESPONSIBLE PARENTING;

22 (IV) ACKNOWLEDGE AND DESCRIBE THE INTEGRAL ROLE PARENTS  
23 HAVE IN ASSISTING STUDENT LEARNING;24 (V) DEVELOP POLICIES AND PRACTICES THAT WELCOME PARENTS  
25 IN THE SCHOOL LEARNING COMMUNITY;26 (VI) SEEK PARENTAL SUPPORT AND ASSISTANCE IN FULFILLING  
27 THE SCHOOL'S ACADEMIC AND COMMUNITY GOALS;28 (VII) RECOGNIZE COMMUNITY RESOURCES THAT STRENGTHEN  
29 STUDENT LEARNING, SCHOOL PROGRAMS, AND FAMILY PRACTICES; AND30 (VIII) REQUIRE REGULAR PUBLICATION OF AN UPDATED SCHOOL  
31 ACTIVITY LIST.32 (C) (1) EACH SCHOOL SHALL PREPARE AGE AND GRADE APPROPRIATE  
33 PARENTAL INVOLVEMENT FAMILY KITS.

(2) EACH KIT SHALL INCLUDE:

(I) A COPY OF THE SCHOOL'S PLAN;

5 (III) A LIST AND DESCRIPTION OF THE WAYS FOR PARENTS TO  
6 BECOME INVOLVED IN THE SCHOOL AND THEIR STUDENT'S EDUCATION;

9 (V) A DESCRIPTION OF THE SYSTEM BY WHICH PARENTS AND  
10 TEACHERS CAN COMMUNICATE IN A REGULAR, TWO-WAY, AND MEANINGFUL  
11 MANNER WITH EACH OTHER AND THE SCHOOL PRINCIPAL;

12 (VI) A SURVEY FOR PARENTS THAT ASSESSES EACH PARENT'S  
13 INTEREST IN VARIOUS VOLUNTEER ACTIVITIES SCHEDULED FOR THE SCHOOL YEAR  
14 AND DETERMINES HOW FREQUENTLY A PARENT VOLUNTEER WOULD LIKE TO  
15 PARTICIPATE, INCLUDING THE OPTION OF JUST ONE TIME PER YEAR;

16 (VII) A DESCRIPTION OF AVAILABLE SCHOOL AND COMMUNITY  
17 RESOURCES, INCLUDING THE SCHOOL'S PARENT CENTER; AND

18 (VIII) A WRITTEN DESCRIPTION OF THE PARENTAL INVOLVEMENT  
19 GRADING SYSTEM.

20 (D) (1) AT THE BEGINNING OF EACH SCHOOL YEAR, THE SCHOOL SHALL  
21 HOLD A "PARENTS MAKE THE DIFFERENCE" EVENING.

22 (2) AT THE MEETING, PARENTS SHALL BE GIVEN:

23 (I) A REPORT ON THE STATE OF THE SCHOOL;

24 (II) AN OVERVIEW OF THE SCHOOL YEAR, INCLUDING:

25 1. WHAT STUDENTS WILL BE LEARNING;

(III) A KIT FOR EACH STUDENT IN THE SCHOOL

1 (IV) A COPY OF THE SCHOOL'S PROCESS FOR RESOLVING PARENTAL  
2 CONCERNS INCLUDING HOW TO DEFINE A PROBLEM AND WHOM TO APPROACH AND  
3 THE APPROPRIATE CONTACT INFORMATION; AND

4 (V) AN EXPLANATION OF THE PARENTAL INVOLVEMENT GRADING  
5 SYSTEM.

6 (E) (1) EACH LOCAL SCHOOL DISTRICT SHALL DEVELOP AND IMPLEMENT A  
7 PARENTAL INVOLVEMENT GRADING SYSTEM.

8 (2) THE SYSTEM SHALL INCLUDE:

9 (I) A LIST OF THE ACTIVITIES THAT PARENTS WERE INVITED TO  
10 PARTICIPATE IN THROUGHOUT THE SCHOOL YEAR;

11 (II) THE NUMBER, AGE, AND GRADE OF THE STUDENTS IN THE  
12 DISTRICT FOR EACH PARENT;

13 (III) A METHODOLOGY FOR DETERMINING HOW THE PARENTS'  
14 INVOLVEMENT WILL BE EVALUATED;

15 (IV) A DESCRIPTION OF A SCHOOL'S REQUIREMENTS REGARDING  
16 COLLECTION OF PARENTAL INVOLVEMENT DATA AND REPORTING OF DATA TO THE  
17 LOCAL SCHOOL DISTRICT;

18 (V) NOTICE OF THE MANNER BY WHICH PARENTS WILL BE  
19 NOTIFIED OF THE GRADE; AND

20 (VI) ANY OTHER INFORMATION RELEVANT TO THE  
21 DETERMINATION OR ISSUANCE OF THE GRADE.

22 (F) (1) USING THE RESULTS OF THE PARENT SURVEY REQUIRED UNDER  
23 SUBSECTION (C) OF THIS SECTION, EACH SCHOOL SHALL PUBLISH A VOLUNTEER  
24 RESOURCE BOOK.

25 (2) THE VOLUNTEER RESOURCE BOOK SHALL:

26 (I) LIST THE INTERESTS AND AVAILABILITY OF PARENT  
27 VOLUNTEERS; AND

28 (II) BE USED BY SCHOOL STAFF ONLY.

29 (G) (1) THE PRINCIPAL OF EACH SCHOOL SHALL DESIGNATE ONE STAFF  
30 MEMBER AS A PARENT FACILITATOR.

31 (2) THE PARENT FACILITATOR SHALL ORGANIZE STAFF TRAINING THAT  
32 ENHANCES UNDERSTANDING OF:

33 (I) EFFECTIVE PARENTAL INVOLVEMENT STRATEGIES; AND

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take  
7 effect July 1, 2004.
