Maryland Breast Cancer Research Fund - Income Tax Checkoff

- 3 FOR the purpose of establishing the Maryland Breast Cancer Research Fund within
- 4 the Department of Health and Mental Hygiene to be used to provide grants for
- 5 breast cancer research; requiring that all expenditures from the Fund be made
- 6 only through an appropriation in the annual State budget or through an
- 7 approved budget amendment; requiring the Secretary of Health and Mental
- 8 Hygiene to adopt certain regulations; requiring the Secretary to submit a
- 9 certain report each year to the General Assembly on the administration of the
- Fund; requiring the Comptroller to include a checkoff on individual income tax
- return forms for voluntary contributions to the Fund and to include certain

3	(6) MONEYS EXPENDED FROM THE FUND FOR BREAST CANCER RESEARCH ARE SUPPLEMENTAL AND ARE NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE APPROPRIATED TO THE DEPARTMENT FOR BREAST CANCER RESEARCH.
7	(7) ALL EXPENDITURES FROM THE FUND SHALL BE MADE ONLY IN ACCORDANCE WITH AN APPROPRIATION APPROVED BY THE GENERAL ASSEMBLY IN THE ANNUAL STATE BUDGET OR THROUGH AN APPROVED BUDGET AMENDMENT UNDER §§ 7-209 AND 7-210 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
