## 1 AN ACT concerning

## 2 Real Property - Display of United States Flag by Homeowners and Tenants

- 3 FOR the purpose of providing that a homeowner or tenant may not be prohibited from
- displaying on the premises of the property in which the homeowner or tenant is
- 5 entitled to reside one flag of the United States in a certain manner and subject
- 6 to certain reasonable rules and regulations regardless of the terms of any
- 7 contract, deed, covenant, restriction, instrument, declaration, rule, bylaw, lease
- 8 agreement, rental agreement, or any other document concerning the display of
- 9 flags or decorations on the property; providing that the terms of any contract,
- deed, covenant, restriction, instrument, declaration, rule, bylaw, lease
- agreement, rental agreement, or any other document concerning the display of
- flags or decorations by a homeowner or tenant on residential property may not
- prohibit or unduly restrict the right of a homeowner or tenant to display in a
- certain manner and subject to certain reasonable rules and regulations one flag
- of the United States on the premises of the property in which the homeowner or

- 14 (B) REGARDLESS OF THE TERMS OF ANY CONTRACT, DEED, COVENANT,

## **HOUSE BILL 1017**

- 1 (2) BEFORE ADOPTING ANY RULES OR REGULATIONS UNDER
- 2 PARAGRAPH (1) OF THIS SUBSECTION, THE BOARD OF DIRECTORS OF THE
- 3 CONDOMINIUM, HOMEOWNERS ASSOCIATION, OR HOUSING COOPERATIVE, OR THE
- 4 LANDLORD SHALL:
- 5 (I) HOLD A PUBLIC HEARING ON THE PROPOSED RULES AND
- 6 REGULATIONS FOR THE PURPOSE OF PROVIDING AFFECTED HOMEOWNERS AND
- 7 TENANTS AN OPPORTUNITY TO BE HEARD: AND
- 8 (II) PROVIDE ADVANCE NOTICE OF THE TIME AND PLACE OF THE
- 9 PUBLIC HEARING BY PUBLISHING THE NOTICE IN A COMMUNITY NEWSLETTER, ON A
- 10 COMMUNITY BULLETIN BOARD, OR BY OTHER MEANS REASONABLY CALCULATED TO
- 11 INFORM THE AFFECTED HOMEOWNERS AND TENANTS.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 13 construed to apply retroactively and shall be applied to and interpreted to affect,
- 14 regardless of the date of adoption or effectiveness, any contract, deed, covenant,
- 15 restriction, instrument, declaration, rule, bylaw, lease agreement, rental agreement,
- 16 or any other document concerning the display of flags or decorations by a homeowner
- 17 or tenant on residential property.
- 18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take
- 19 effect October 1, 2004.
