A BILL ENTITLED

1 AN ACT concerning

Alcohol and Drug Abuse Administration - Halfway Houses - Zoning Classification

4 FOR the purpose of providing that certain halfway houses are considered a certain

- 5 type of dwelling for certain purposes; authorizing certain halfway houses to be
- 6 located in certain residential zones; prohibiting certain halfway houses from
- 7 being subject to certain exceptions, permits, or procedures; providing that this
- 8 Act supersedes certain ordinances, rules, or regulations; and generally relating
- 9 to the Alcohol and Drug Abuse Administration and halfway houses.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

Article - Health - General

18 8-406.

19 (A) THIS SECTION APPLIES ONLY TO HALFWAY HOUSES REGULATED BY THE 20 ADMINISTRATION.

21 (B) A HALFWAY HOUSE THAT ADMITS AT LEAST FOUR BUT NOT MORE THAN 22 EIGHT INDIVIDUALS IS:

- 23 (1) DEEMED CONCLUSIVELY TO BE A SINGLE-FAMILY DWELLING; AND
- 24 (2) PERMITTED TO BE LOCATED IN ALL RESIDENTIAL ZONES.

1 (C) A HALFWAY HOUSE THAT ADMITS AT LEAST NINE BUT NOT MORE THAN 2 SIXTEEN INDIVIDUALS IS:

- 3 (1) DEEMED CONCLUSIVELY A TO BE A MULTIFAMILY DWELLING; AND
- 4 (2) PERMITTED TO BE LOCATED IN ZONES OF SIMILAR DENSITY.

5 (D) A HALFWAY HOUSE MAY NOT BE SUBJECT TO ANY SPECIAL EXCEPTION,
6 CONDITIONAL USE PERMIT, OR PROCEDURE THAT DIFFERS FROM THAT REQUIRED
7 FOR A SINGLE-FAMILY DWELLING OR A MULTIFAMILY DWELLING OF SIMILAR
8 DENSITY IN THE SAME ZONE.

9 (E) A GENERAL ZONING ORDINANCE, RULE, OR REGULATION OF ANY
10 POLITICAL SUBDIVISION THAT CONFLICTS WITH THE PROVISIONS OF THIS SECTION
11 OR ANY RULE OR REGULATION THAT CARRIES OUT THE PURPOSES OF THIS SECTION
12 IS SUPERSEDED BY THIS SECTION TO THE EXTENT OF ANY CONFLICT.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 14 effect October 1, 2004.
