BE IT ENACTED BY THE GENERAL ASSEMBLY OF 20 21 MARYLAND, That the Laws of Maryland read as follows: 22 **Article - Natural Resources** 23 4-11A-16. [The] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE owner 24 25 of any wharf or other structure constructed on or about the water and approved by the

26 corps of engineers, shall have exclusive use, for the purpose of growing and harvesting

Below the owner's wharf or structure; [and]

- 1 [(2)] (II) In [Calvert, Howard, St. Mary's,] HOWARD and Talbot counties
- 2 only, within 5 feet of the owner's wharf or structure, oysters grown in trays, baskets,
- 3 or containers that are attached to a private pier or wharf by lines or ropes that are the
- 4 property of the owner of the pier or wharf; AND
- 5 (III) IN CALVERT AND ST. MARY'S COUNTIES ONLY, WITHIN 15 FEET
- 6 OF THE OWNER'S WHARF OR STRUCTURE, OYSTERS GROWN IN TRAYS, BASKETS, OR
- 7 CONTAINERS THAT ARE ATTACHED TO A PRIVATE PIER OR WHARF BY LINES OR
- 8 ROPES THAT ARE THE PROPERTY OF THE OWNER OF THE PIER OR WHARF.
- 9 (2) A PERSON WHO GROWS AND HARVESTS SHELLFISH IN CALVERT OR 10 ST. MARY'S COUNTY UNDER PARAGRAPH (1) OF THIS SUBSECTION MAY NOT:
- 11 (I) INFRINGE ON THE RIPARIAN RIGHTS OF AN ADJACENT
- 12 PROPERTY OWNER; OR
- 13 (II) OBSTRUCT ACCESS TO A LEASED OYSTER BOTTOM OR NATURAL

- 16 (a) Except as otherwise specifically provided in this title, a person who
- 17 violates any provision of this title is guilty of a misdemeanor and, upon conviction, is
- 18 subject to a fine not exceeding \$500, with costs imposed in the discretion of the court.
- 19 (b) Unless another penalty is specifically provided elsewhere in this title, any
- 20 person found guilty of a second or subsequent violation of any provision of this title is
- 21 subject to a fine not exceeding \$1,000, or imprisonment not exceeding one year, or
- 22 both, with costs imposed in the discretion of the court. For the purpose of this
- 23 subsection, a second or subsequent violation is one which has occurred within two
- 24 years of any prior violation of this title.
- 25 (c) In addition to any administrative penalty provided in this title, violation of
- 26 any rule or regulation adopted by any unit within the Department pursuant to the
- 27 provisions of this title is a misdemeanor and is punishable as provided in subsections
- 28 (a) and (b).
- 29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 30 October 1, 2004.
