- WHEREAS, William Donald Schaefer, a lifelong Maryland resident, has held
- 16 elective public office in State and local government in Maryland for 45 years, having
- 17 served for 12 years as a member of the Baltimore City Council from 1955 to 1967, for
- 18 4 years as President of the Baltimore City Council from 1967 to 1971, for 15 years as
- 19 Mayor of the City of Baltimore from 1971 to 1986, for 8 years as Governor from 1987
- 20 to 1995 and, after a brief hiatus, most recently, for the past 5 years as State
- 21 Comptroller since 1999; and
- WHEREAS, In addition to his service as an elected official, Mr. Schaefer has
- 23 endeavored to share his passion for public service with individuals who aspire to take
- 24 up that mantel, as evidenced by his appointment to the Schaefer Chair at the
- 25 University of Maryland's School of Public Affairs in conjunction with the Johns
- 26 Hopkins University Institute for Policy Studies, and as further evidenced by his
- 27 involvement with numerous civic and charitable organizations and service on the
- 28 boards of several nonprofit organizations and institutions of higher education in the
- 29 State: and
- 30 WHEREAS, It is in the State's interest to encourage young people to pursue
- 31 education and training that leads to employment opportunities in public service at all
- 32 levels of government; and
- WHEREAS, It is most fitting that William Donald Schaefer, whose career is a

- 35 spent in public service, be honored by the creation of a scholarship program to provide
