A BILL ENTITLED

1 AN ACT concerning

2 **Howard County - Alcoholic Beverages Licenses - Out-of-State Restriction**
3 **Ho. Co. 15-04**

4 FOR the purpose of prohibiting in Howard County certain alcoholic beverages
5 licenses from being issued, except by renewal, to persons, corporations, or
6 limited liability companies that hold an alcoholic beverages license in any other
7 state or Washington, D.C.; and generally relating to alcoholic beverages licenses
8 in Howard County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article 2B - Alcoholic Beverages**

18 (b-3) (1) In Anne Arundel County, a Class A or Class D beer, beer and light
19 wine, or beer, wine and liquor license may not be issued except by way of renewal to
20 a person, corporation, or limited liability company holding an alcoholic beverage
21 license in any other state, or Washington, D.C.

22 (2) In Baltimore City, a Class A or Class D beer, beer and light wine, or
23 beer, wine and liquor license may not be issued except by way of renewal to a person,
24 corporation, or limited liability company holding an alcoholic beverage license in any
25 other state.

26 (3) In Baltimore County, a Class A or Class D beer, beer and light wine,
27 or beer, wine and liquor license may not be issued, except by way of renewal, to a

1 person, corporation, or limited liability company holding an alcoholic beverages
2 license in any other state or in Washington, D.C.

3 (4) In Calvert County and St. Mary's County, a Class A or Class D beer,
4 beer and light wine, or beer, wine and liquor license may not be issued, except by way
5 of renewal, to a person, corporation, or limited liability company holding an alcoholic
6 beverages license in any other state or in Washington, D.C.

7 (5) In Charles County, a Class A or Class D beer, beer and light wine, or
8 beer, wine and liquor license may not be issued, except by way of renewal, to a person,
9 corporation, or limited liability company holding an alcoholic beverages license in any
10 other state or in Washington, D.C.

11 (6) IN HOWARD COUNTY, A CLASS A OR CLASS D BEER, BEER AND LIGHT
12 WINE, OR BEER, WINE AND LIQUOR LICENSE MAY NOT BE ISSUED, EXCEPT BY WAY
13 OF RENEWAL, TO A PERSON, CORPORATION, OR LIMITED LIABILITY COMPANY
14 HOLDING AN ALCOHOLIC BEVERAGES LICENSE IN ANY OTHER STATE OR IN
15 WASHINGTON, D.C.

16 (7) In Washington County, a Class A or Class D beer, beer and light wine,
17 or beer, wine and liquor license may not be issued, except by way of renewal, to a
18 person, corporation, or limited liability company holding an alcoholic beverages
19 license in any other state or in Washington, D.C.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2004.
