A BILL ENTITLED

1 AN ACT concerning

2 **Leonardtown - Alcoholic Beverages - Location of Premises with Class B**
3 **License**

4 FOR the purpose of exempting applications for Class B (on-sale) beer, wine and liquor
5 licenses for premises in Leonardtown from the prohibition against alcoholic
6 beverages license applications being approved by the Board of County
7 Commissioners for premises in St. Mary's County within a certain distance of
8 certain schools or places of worship; making technical corrections; and generally
9 relating to the issuance of alcoholic beverages licenses in St. Mary's County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article 2B - Alcoholic Beverages**

18 9-219.

19 (a) This section applies only in St. Mary's County.

20 (b) (1) [The] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS
21 SUBSECTION, THE Board of License Commissioners may not approve any application
22 for a license to sell alcoholic beverages in any building the nearest wall of which
23 measured in a direct line is within 300 feet of the nearest point of the main buildings
24 of any public or nonpublic kindergarten, elementary or secondary school, church or
25 other place of worship.

26 (2) [This paragraph] PARAGRAPH (1) OF THIS SUBSECTION is not
27 applicable:

1 (I) TO AN APPLICATION FOR A CLASS B (ON-SALE) BEER, WINE AND
2 LIQUOR LICENSE FOR A PREMISES LOCATED IN LEONARDTOWN; OR

3 (II) [in] IN the event any school, church, or other place of worship
4 locates its building within 300 feet of any licensed premises after the licensed
5 premises are there established.

6 (c) The Board of License Commissioners may not issue or transfer an off-sale
7 alcoholic beverages license of any class for the use in a business that is intended to be
8 operated as a drive-through purchase facility where alcoholic beverages are to be sold
9 at retail and dispensed through a window or door to a purchaser in or on a motor
10 vehicle for off-premises consumption.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 June 1, 2004.
