- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (a) In addition to the specific powers granted and duties imposed by this title,
- 20 the Administration has the powers and duties set forth in this section.

- 1 (b) The Administration may adopt rules and regulations to carry out: 2 (1) Those provisions of the Maryland Vehicle Law that relate to or are 3 administered and enforced by the Administration; and The provisions of any other law that the Administration is authorized 4 (2) 5 to administer and enforce. 6 (1) The Administration shall maintain as many offices in this State as (c) 7 the Administrator considers necessary to carry out the powers and duties of the 8 Administration. 9 Each office shall be open on the days and during the hours that the (2) 10 Secretary determines are needed to serve the public. 11 (1)With the approval of the Secretary, the Administration shall employ 12 the deputies, subordinate officers, clerks, investigators, and other employees 13 necessary to carry out the powers and duties of the Administration. 14 Except as otherwise provided by law, and subject to § 2-103.4 of this 15 article, each deputy, officer, and employee of the Administration: 16 (i) Is in the State Personnel Management System; and 17 (ii) Is entitled to the salary provided in the pay plan established 18 under Title 8, Subtitle 1 of the State Personnel and Pensions Article. Except as provided in paragraph (2) of this subsection, the] THE 19 (e) [(1)]20 Administration may delegate to the Office of Administrative Hearings the power and 21 authority under the Maryland Vehicle Law to conduct hearings under this article and 22 render [proposed findings of fact and proposed conclusions of law. 23 The Administration may delegate to the Office of Administrative 24 Hearings the power and authority under the Maryland Vehicle Law to render] final decisions in hearings conducted under [§§ 13-705.1, 21-1005, and 22-218, and Title 16, Subtitles 1 through 4 of] this article.
