Immunities and Prohibited Actions - Livestock Activities" 11 12 Annotated Code of Maryland (2002 Replacement Volume and 2003 Supplement) 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: 16 **Article - Courts and Judicial Proceedings** SUBTITLE 12. IMMUNITIES AND PROHIBITED ACTIONS - LIVESTOCK ACTIVITIES. 17 18 5-1201. 19 IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS (A) 20 INDICATED. "ENGAGE IN LIVESTOCK ACTIVITY" INCLUDES: 21 (B) (1) LEADING, EXHIBITING, TRAINING, RACING, SHOWING, RIDING, 22 23 GROOMING, OR DRIVING LIVESTOCK; 24 (II)BEING A PASSENGER IN A VEHICLE PULLED BY LIVESTOCK:

SHOWING LIVESTOCK FOR POTENTIAL SALE;

- 1 (IV) ASSISTING IN MEDICAL TREATMENT OF LIVESTOCK; AND
- 2 (V) ASSISTING A PARTICIPANT, LIVESTOCK ACTIVITY SPONSOR, OR 3 LIVESTOCK PROFESSIONAL.
- 4 (2) "ENGAGE IN LIVESTOCK ACTIVITY" DOES NOT INCLUDE BEING A
- 5 SPECTATOR AT A LIVESTOCK ACTIVITY, UNLESS THE SPECTATOR PLACES HIMSELF
- 6 OR HERSELF IN IMMEDIATE PROXIMITY TO LIVESTOCK ACTIVITY.
- 7 (C) (1) "LIVESTOCK" MEANS ANY CATTLE, OXEN, BISON, HOG, SHEEP, GOAT, 8 OR EQUINE.
- 9 (2) "LIVESTOCK" INCLUDES ANIMALS OF THE FAMILIES BOVIDAE, 10 CERVIDAE, AND ANTILOCAPRIDAE, AND BIRDS OF THE RATITE GROUP.
- 11 (D) "LIVESTOCK ACTIVITY" INCLUDES:
- 12 (1) SHOWS, FAIRS, SALES, COMPETITIONS, PERFORMANCES, OR
- 13 PARADES THAT INVOLVE ONE OR MORE BREEDS OF LIVESTOCK;
- 14 (2) ANY LIVESTOCK DISCIPLINE, INCLUDING RODEOS, AUCTIONS,
- 15 DRIVING, PULLING, JUDGING, CUTTING, AND SHOWING;
- 16 (3) LIVESTOCK TRAINING OR TEACHING ACTIVITIES, OR BOTH;
- 17 (4) BOARDING OR PASTURING LIVESTOCK, INCLUDING NORMAL DAILY
- 18 CARE;
- 19 (5) INSPECTING OR EVALUATING LIVESTOCK BELONGING TO ANOTHER,
- 20 WHETHER OR NOT THE OWNER HAS RECEIVED MONETARY CONSIDERATION OR
- 21 OTHER THING OF VALUE FOR THE USE OF THE LIVESTOCK OR IS ALLOWING A
- 22 PROSPECTIVE PURCHASER OF THE LIVESTOCK TO INSPECT OR EVALUATE THE
- 23 LIVESTOCK;
- 24 (6) DRIVES, RIDES, TRIPS, HUNTS, OR OTHER LIVESTOCK ACTIVITIES OF
- 25 ANY TYPE, HOWEVER INFORMAL OR IMPROMPTU;
- 26 (7) PLACING OR REPLACING HORSESHOES ON AN EQUINE OR
- 27 OTHERWISE PREPARING LIVESTOCK FOR SHOW; AND
- 28 (8) EXAMINING OR ADMINISTERING MEDICAL TREATMENT TO A FARM
- 29 ANIMAL BY A VETERINARIAN.
- 30 (E) (1) "LIVESTOCK ACTIVITY SPONSOR" MEANS AN INDIVIDUAL, GROUP.
- 31 CLUB, PARTNERSHIP, OR CORPORATION, WHETHER OR NOT THE SPONSOR IS
- 32 OPERATING FOR PROFIT OR NONPROFIT, THAT SPONSORS, ORGANIZES, OR PROVIDES
- 33 THE FACILITIES FOR A LIVESTOCK ACTIVITY.
- 34 (2) "LIVESTOCK ACTIVITY SPONSOR" INCLUDES LIVESTOCK CLUBS, 4-H
- 35 CLUBS, FUTURE FARMERS OF AMERICA CHAPTERS, SCHOOL AND COLLEGE
- 36 SPONSORED CLASSES, PROGRAMS, AND ACTIVITIES, THERAPEUTIC RIDING

- 1 PROGRAMS, AND OPERATORS, INSTRUCTORS, AND PROMOTERS OF LIVESTOCK
- 2 FACILITIES, INCLUDING BARNS, STABLES, CLUBHOUSES, PONY RIDE STRINGS, FAIRS,
- 3 AND ARENAS AT WHICH AN ACTIVITY IS HELD.
- 4 (F) "LIVESTOCK PROFESSIONAL" MEANS A PERSON ENGAGED FOR
- 5 COMPENSATION IN:
- 6 (1) INSTRUCTING A PARTICIPANT;
- 7 (2) RENTING LIVESTOCK TO A PARTICIPANT FOR THE PURPOSE OF 8 ENGAGING IN LIVESTOCK ACTIVITY; OR
- 9 (3) RENTING EQUIPMENT OR TACK TO A PARTICIPANT.
- 10 (G) (1) "INHERENT RISKS OF LIVESTOCK ACTIVITIES" MEANS THE DANGERS
- 11 OR CONDITIONS THAT ARE AN INTEGRAL PART OF LIVESTOCK ACTIVITIES.
- 12 (2) "INHERENT RISKS OF LIVESTOCK ACTIVITIES" INCLUDES:
- 13 (I) THE PROPENSITY OF LIVESTOCK TO BEHAVE IN WAYS THAT
- 14 MAY RESULT IN INJURY TO PERSONS ON OR AROUND THEM;
- 15 (II) THE UNPREDICTABILITY OF LIVESTOCK'S REACTION TO SUCH
- 16 THINGS AS SOUNDS, SUDDEN MOVEMENT, AND UNFAMILIAR OBJECTS, PERSONS, OR
- 17 ANIMALS:
- 18 (III) HAZARDS SUCH AS SURFACE AND SUBSURFACE CONDITIONS
- 19 UNKNOWN TO THE LIVESTOCK ACTIVITY SPONSOR;
- 20 (IV) COLLISIONS WITH OTHER LIVESTOCK OR OBJECTS; AND
- 21 (V) THE POTENTIAL OF TACK TO BECOME DISLODGED OR MOVE IN
- 22 WAYS THAT MAY RESULT IN INJURY TO PERSONS ON OR AROUND LIVESTOCK
- 23 ACTIVITIES.
- 24 (H) "PARTICIPANT" MEANS ANY PERSON, WHETHER AMATEUR OR
- 25 PROFESSIONAL, WHO ENGAGES IN LIVESTOCK ACTIVITY, WHETHER OR NOT A FEE IS
- 26 PAID TO PARTICIPATE IN THE LIVESTOCK ACTIVITY.

- 28 (A) THE GENERAL ASSEMBLY RECOGNIZES THAT PERSONS WHO ENGAGE IN
- 29 LIVESTOCK ACTIVITIES MAY INCUR INJURIES AS A RESULT OF THE RISKS INVOLVED
- 30 IN THOSE ACTIVITIES EVEN IN THE ABSENCE OF ANY FAULT OR NEGLIGENCE ON
- 31 THE PART OF PERSONS OR ENTITIES THAT SPONSOR, PARTICIPATE IN, OR ORGANIZE
- 32 THOSE ACTIVITIES.
- 33 (B) THE GENERAL ASSEMBLY FINDS THAT THE STATE AND ITS CITIZENS
- 34 DERIVE NUMEROUS ECONOMIC AND PERSONAL BENEFITS FROM LIVESTOCK
- 35 ACTIVITIES.

- 1 (C) THE INTENT OF THIS SUBTITLE IS TO ENCOURAGE LIVESTOCK ACTIVITIES
- 2 BY LIMITING THE CIVIL LIABILITY OF LIVESTOCK ACTIVITY SPONSORS,
- 3 PARTICIPANTS, AND LIVESTOCK PROFESSIONALS INVOLVED IN LIVESTOCK
- 4 ACTIVITIES.
- 5 5-1203.
- 6 (A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A LIVESTOCK
- 7 ACTIVITY SPONSOR, A PARTICIPANT, OR A LIVESTOCK PROFESSIONAL ACTING IN
- 8 GOOD FAITH AND IN ACCORDANCE WITH THE STANDARDS OF THE LIVESTOCK
- 9 INDUSTRY IS NOT LIABLE FOR INJURIES TO ANY PERSON THAT RESULT FROM THE
- 10 INHERENT RISKS OF LIVESTOCK ACTIVITIES.
- 11 (B) THIS SECTION DOES NOT PROHIBIT OR LIMIT THE LIABILITY OF A
- 12 LIVESTOCK ACTIVITY SPONSOR, PARTICIPANT, OR LIVESTOCK PROFESSIONAL, IF
- 13 THE LIVESTOCK ACTIVITY SPONSOR, PARTICIPANT, OR LIVESTOCK PROFESSIONAL:
- 14 (1) COMMITS AN ACT OR OMISSION THAT CONSTITUTES WILLFUL OR
- 15 WANTON DISREGARD FOR THE SAFETY OF ANY PERSON ENGAGED IN A LIVESTOCK
- 16 ACTIVITY, AND THAT ACT OR OMISSION CAUSES THE INJURY;
- 17 (2) INTENTIONALLY INJURES A PERSON ENGAGED IN A LIVESTOCK
- 18 ACTIVITY;
- 19 (3) PROVIDES EQUIPMENT OR TACK THAT IS FAULTY TO THE EXTENT
- 20 THAT IT CAUSES THE INJURY, EXCEPT FOR EQUIPMENT OR TACK USED IN
- 21 LIVESTOCK ACTIVITIES SPONSORED BY YOUTH ORGANIZATIONS IN WHICH YOUTH
- 22 PARTICIPANTS SHARE EQUIPMENT OR TACK AMONG THEMSELVES;
- 23 (4) PROVIDES THE LIVESTOCK AND FAILS TO MAKE A REASONABLE
- 24 EFFORT TO DETERMINE THE ABILITY OF THE PARTICIPANT TO MANAGE THE
- 25 PARTICULAR LIVESTOCK BASED UPON THE PARTICIPANT'S REPRESENTATION OF
- 26 THE PARTICIPANT'S ABILITY; OR
- 27 (5) OWNS, LEASES, RENTS, OR OTHERWISE IS IN LAWFUL POSSESSION
- 28 AND CONTROL OF THE LAND OR FACILITIES ON WHICH THE PARTICIPANT
- 29 SUSTAINED INJURIES BECAUSE OF A DANGEROUS CONDITION KNOWN TO THE
- 30 LIVESTOCK ACTIVITY SPONSOR, LIVESTOCK PROFESSIONAL, OR OTHER PERSON, AND
- 31 NOT MADE KNOWN TO THE PARTICIPANT.
- 32 (C) A PARTICIPANT IN A LIVESTOCK SHOW, LIVESTOCK SALE, OR RODEO
- 33 SHALL BE PRESUMED TO BE COMPETENT IN THE HANDLING OF LIVESTOCK IF AN
- 34 ENTRY FORM IS REQUIRED FOR THE ACTIVITY AND THAT FORM IS SIGNED BY THE
- 35 PARTICIPANT.
- 36 (D) A LIVESTOCK ACTIVITY SPONSOR MAY NOT BE HELD VICARIOUSLY LIABLE
- 37 FOR THE ACTS OR OMISSIONS OF A PARTICIPANT OR A LIVESTOCK PROFESSIONAL.
- 38 (E) TWO OR MORE PERSONS MAY AGREE, IN WRITING, TO EXTEND THE
- 39 WAIVER OF LIABILITY UNDER THIS SUBTITLE.

- 2 (A) THIS SUBTITLE DOES NOT CREATE A DUTY FOR A LIVESTOCK ACTIVITY 3 SPONSOR, LIVESTOCK PROFESSIONAL, OR OTHER PERSON TO GIVE A WARNING TO:
- 4 (1) A PARTICIPANT ENGAGED IN A LIVESTOCK ACTIVITY WITH THE 5 PARTICIPANT'S OWN LIVESTOCK;
- 6 (2) A PARTICIPANT WHOM THE LIVESTOCK ACTIVITY SPONSOR,
- 7 LIVESTOCK PROFESSIONAL, OR OTHER PERSON KNOWS TO POSSESS REASONABLE
- 8 KNOWLEDGE OF OR EXPERIENCE WITH THE INHERENT RISK OF LIVESTOCK
- 9 ACTIVITIES; OR
- 10 (3) A PARTICIPANT WHO HAS REPRESENTED TO THE LIVESTOCK
- 11 ACTIVITY SPONSOR, LIVESTOCK PROFESSIONAL, OR OTHER PERSON THAT THE
- 12 PARTICIPANT POSSESSES REASONABLE KNOWLEDGE OR EXPERIENCE WITH THE
- 13 INHERENT RISKS OF LIVESTOCK ACTIVITIES.
- 14 (B) THE STATE ENCOURAGES EACH LIVESTOCK ACTIVITY SPONSOR AND
- 15 LIVESTOCK PROFESSIONAL TO POST AND MAINTAIN SIGNS THAT CONTAIN THE
- 16 WARNING NOTICE SPECIFIED IN SUBSECTION (E) OF THIS SECTION IN A CLEARLY
- 17 VISIBLE LOCATION ON OR NEAR STABLES, CORRALS, BARNYARDS, BARNS, FARM
- 18 ENTRANCES, OR OTHER AREAS WHERE THE LIVESTOCK PROFESSIONAL OR THE
- 19 LIVESTOCK ACTIVITY SPONSOR CONDUCTS LIVESTOCK ACTIVITIES.
- 20 (C) THE STATE ENCOURAGES:
- 21 (1) EACH WRITTEN CONTRACT ENTERED INTO BY A LIVESTOCK
- 22 PROFESSIONAL OR BY A LIVESTOCK ACTIVITY SPONSOR PROVIDING PROFESSIONAL
- 23 SERVICES OR INSTRUCTIONS, OR THE RENTAL OF EQUIPMENT, SUPPLIES, TACK, OR
- 24 LIVESTOCK TO A PARTICIPANT, WHETHER THE CONTRACT INVOLVES LIVESTOCK
- 25 ACTIVITIES ON OR OFF THE LOCATION, TO CONTAIN THE PRINTED WARNING
- 26 SPECIFIED IN SUBSECTION (E) OF THIS SECTION; AND
- 27 (2) OTHER LITERATURE, INCLUDING FLYERS, BROCHURES, AND OTHER
- 28 ANNOUNCEMENTS ADDRESSING LIVESTOCK ACTIVITIES TO CONTAIN THE PRINTED
- 29 WARNING SPECIFIED IN SUBSECTION (E) OF THIS SECTION.
- 30 (D) (1) A PARTICIPANT, OR A PARENT OR GUARDIAN OF A MINOR
- 31 PARTICIPANT, WHO KNOWINGLY SIGNS A CONTRACT BEFORE PARTICIPATION IN A
- 32 LIVESTOCK ACTIVITY OR WHO VOLUNTARILY PARTICIPATES IN ANY ACTIVITY
- 33 WHERE THE INHERENT RISKS ARE KNOWN, IS DEEMED TO HAVE WAIVED THE RIGHT
- 34 TO BRING AN ACTION AGAINST THE LIVESTOCK PROFESSIONAL OR LIVESTOCK
- 35 ACTIVITY SPONSOR FOR ANY INJURY, DAMAGE, LOSS, OR DEATH ARISING OUT OF

- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
