1 AN ACT concerning

2 **Motor Vehicle Law - Driving without Authorization - Penalties**

3 FOR the purpose of increasing the penalties for a violation of driving or attempting to  
4 drive a motor vehicle on a highway in the State without holding a certain  
5 driver's license or otherwise without authorization to drive a motor vehicle in  
6 the State to include a potential maximum term of imprisonment; and generally  
7 relating to penalties for driving a motor vehicle without authorization in the  
8 State.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

**Article - Transportation**

2 16-101.

3 (a) An individual may not drive or attempt to drive a motor vehicle on any  
4 highway in this State unless:

5 (1) The individual holds a driver's license issued under this title;

6 (2) The individual is expressly exempt from the licensing requirements  
7 of this title; or

8 (3) The individual otherwise is specifically authorized by this title to  
9 drive vehicles of the class that the individual is driving or attempting to drive.

10 27-101.

11 (a) It is a misdemeanor for any person to violate any of the provisions of the  
12 Maryland Vehicle Law unless the violation:

13 (1) Is declared to be a felony by the Maryland Vehicle Law or by any  
14 other law of this State; or

15 (2) Is punishable by a civil penalty under the applicable provision of the  
16 Maryland Vehicle Law.

17 (b) Except as otherwise provided in this section, any person convicted of a  
18 misdemeanor for the violation of any of the provisions of the Maryland Vehicle Law is  
19 subject to a fine of not more than \$500.

20 (c) Any person who is convicted of a violation of any of the provisions of the  
21 following sections of this article is subject to a fine of not more than \$500 or  
22 imprisonment for not more than 2 months or both:

24 misrepresentation prohibited");

25 (2) § 14-102 ("Taking or driving vehicle without consent of owner");

28 or registration card or plate");

29 (5) § 14-110 ("Altered or forged documents and plates");

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
4 October 1, 2004.
