A BILL ENTITLED

1 AN ACT concerning

2 **Redhouse Run Stormwater Systems Loan of 1984**

3 FOR the purpose of amending Chapter 389 of the Acts of 1984 to require that the  
4 County Executive and County Council of Baltimore County encumber or expend  
5 the loan proceeds by June 1, 2005; and making this Act an emergency measure.

6 BY repealing and reenacting, with amendments,  
7 Chapter 389 of the Acts of the General Assembly of 1984, as amended by  
8 Chapter 138 of the Acts of the General Assembly of 1985  
9 Section 1

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Chapter 389 of the Acts of 1984, as amended by Chapter 138 of the Acts of**  
13 **1985**

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That:

16 (1) The Board of Public Works may borrow money and incur indebtedness on  
17 behalf of the State of Maryland through a State loan to be known as the Redhouse  
18 Run Stormwater Systems Loan of 1984 in the aggregate principal amount of  
19 \$3,000,000. This loan shall be evidenced by the issuance and sale of State general  
20 obligation bonds authorized by a resolution of the Board of Public Works and issued,  
21 sold and delivered in accordance with the provisions of §§ 19 to 23 of Article 31 of the  
22 Annotated Code of Maryland (1983 Replacement Volume, as amended from time to  
23 time).

24 (2) The bonds issued to evidence this loan or installments thereof may be sold  
25 as a single issue, or may be consolidated and sold as part of a single issue of bonds  
26 under § 2B of Article 31 of the Code.

27 (3) The actual cash proceeds of the sale of the bonds shall be paid to the  
28 Treasurer and shall be first applied to the payment of the expenses of issuing and  
29 delivering the bonds unless funds for this purpose are otherwise provided and

1 thereafter shall be credited on the books of the State Comptroller and expended, upon  
2 approval by the Board of Public Works, for the following public purposes, including  
3 any applicable architects' and engineers' fees: as a grant to the County Executive and  
4 County Council of Baltimore County for the purpose of the reconstruction,  
5 rehabilitation, renovation, reequipping, restoration, and improvement of the  
6 stormwater systems along Redhouse Run in Baltimore County.

7 (4) There is hereby levied and imposed an annual State tax on all assessable  
8 property in the State in rate and amount sufficient to pay the principal of and interest  
9 on the bonds as and when due and until paid in full, such principal to be discharged  
10 within fifteen years of the date of issue of the bonds.

11 (5) Prior to the payment of any funds under the provisions of this Act for the  
12 purposes set forth in Section 1(3) above, the County Executive and County Council of  
13 Baltimore County shall provide at least an equal and matching fund of \$3,000,000. No  
14 part of an applicant's matching fund may be provided, either directly or indirectly,  
15 from funds of the State, whether appropriated or unappropriated. No part of the fund  
16 may consist of real property, in kind contributions, or funds expended prior to the  
17 effective date of this Act. In case of any dispute as to what money or assets may  
18 qualify as matching funds, the Board of Public Works shall determine the matter, and  
19 the Board's decision is final. The County Executive and County Council of Baltimore  
20 County have until June 1, 1987, to present evidence satisfactory to the Board of  
21 Public Works that the matching fund will be provided. If satisfactory evidence is  
22 presented, the Board shall certify this fact to the State Treasurer and the proceeds of  
23 the loan shall be expended for the purposes provided in this Act. If this evidence is not  
24 presented by June 1, 1987, the proceeds of the loan shall be applied to the purposes  
25 authorized in Article 78A, § 3 of the Code.

26 (6) THE COUNTY EXECUTIVE AND COUNTY COUNCIL OF BALTIMORE COUNTY  
27 MUST ENCUMBER OR EXPEND THE LOAN PROCEEDS BY JUNE 1, 2005.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an  
29 emergency measure, is necessary for the immediate preservation of the public health  
30 or safety, has been passed by a yea and nay vote supported by three-fifths of all the  
31 members elected to each of the two Houses of the General Assembly, and shall take  
32 effect from the date it is enacted.
