Public Service Commission - Declaratory Judgments

3 FOR the purpose of providing that certain petitions to challenge the validity or

- 4 application of a regulation of the Public Service Commission must be filed
- 5 within certain periods; providing for the determination of the application of
- 6 certain regulations under certain circumstances; repealing a provision that
- 7 allowed a court to determine the validity of a regulation regardless of whether
- 8 the petitioner had asked the Commission to do so; providing that a party must
- 9 raise an objection to the Commission's decision to act by order rather than by
- 10 regulation in a court proceeding within a certain time period; prohibiting a party
- 11 from appealing the Commission's decision to act by order under certain
- 12 circumstances; providing for the application of this Act; and generally relating to
- 13 the authority of the Public Service Commission.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

20 MARYLAND, That the Laws of Maryland read as follows:

Article - Public Utility Companies

22 3-201.

(a) (1) A PETITION FOR DECLARATORY JUDGMENT CHALLENGING THE VALIDITY OF A REGULATION OF THE COMMISSION MUST BE FILED WITHIN 30 DAYS AFTER THE FINAL REGULATION IS PUBLISHED IN THE MARYLAND REGISTER.

26 (2) (I) The [validity] APPLICATION of a regulation of the Commission 27 may be determined on a petition for declaratory judgment whenever it appears that

1 [the regulation, or] its application[,] actually or potentially interferes with or

2 impairs the legal rights or privileges of the petitioner.

3 (II) A PETITION CHALLENGING THE APPLICATION OF A 4 REGULATION MUST BE FILED WITHIN 30 DAYS AFTER THE COMMISSION ISSUES THE 5 DECISION THAT DETERMINED THE CHALLENGED APPLICATION.

6 [(2) A court may render a declaratory judgment in accordance with 7 paragraph (1) of this subsection whether or not the petitioner has first asked the 8 Commission to determine the validity of the regulation in question.]

9 (B) NOTWITHSTANDING SUBSECTION (A) OF THIS SECTION:

(1) A PARTY TO A COMMISSION PROCEEDING MUST SEEK JUDICIAL
 REVIEW OF THE COMMISSION'S DECISION TO ACT BY ORDER RATHER THAN
 REGULATION WITHIN 30 DAYS AFTER THE COMMISSION ISSUES A FINAL ORDER IN
 THAT PROCEEDING; AND

14 (2) A PARTY WHO REQUESTS THAT THE COMMISSION ACT BY ORDER OR
15 WHO FAILS TO OBJECT TO THE ACTION OF THE COMMISSION BY ORDER RATHER
16 THAN BY REGULATION MAY NOT APPEAL THE COMMISSION'S DECISION TO ACT BY
17 ORDER.

18 [(b)] (C) The Commission shall be made a party to a proceeding under this 19 section.

20 [(c)] (D) A petition under this section shall be filed in the Circuit Court for 21 Baltimore City or the circuit court for the county where the petitioner has its

22 principal office in the State.

23 SECTION 2. AND BE IT FURTHER ENACTED, That notwithstanding any

24 provision of the Administrative Procedure Act, an order of the Public Service

25 Commission issued in a generic or quasi-legislative proceeding after January 1, 1988,

26 and prior to June 1, 2002, is valid and enforceable regardless of whether the order

27 meets the definition of a regulation under § 10-101 of the State Government Article.

28 This section may not be applied or interpreted to affect any court case that is filed or

29 has become final on or before June 1, 2004.

30 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 June 1, 2004.
