A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt - Maryland Consolidated Capital Bond Loan of**
3 **2004, the Maryland Consolidated Capital Bond Loans of 1990, 1991, 1992,**
4 **1993, 1994, 1995, 1996, 1997, 1999, 2002, and 2003, the General Construction**
5 **Loan of 1989, the Water Quality Loans of 1974 and 1975, and the Chesapeake**
6 **Bay Water Quality Loans of 1986, 1987, 1988, and 1989**

7 FOR the purpose of authorizing the creation of a State Debt in the amount of Six
8 Hundred Twenty-Four Million, Seven Hundred Ninety-Two Thousand Dollars
9 (\$624,792,000) the proceeds to be used for certain necessary building,
10 construction, demolition, planning, renovation, conversion, replacement, and
11 capital equipment purchases of this State, for acquiring certain real estate in
12 connection therewith, and for grants to certain subdivisions and other
13 organizations for certain purposes, subject to the requirement that certain
14 grantees provide certain matching funds of a certain type by a certain date;
15 providing generally for the issuance and sale of bonds evidencing the loan;
16 providing for certain unexpended appropriations in prior capital budgets and
17 bond loan acts to be expended for other public projects; altering certain
18 requirements for certain programs in prior capital budget acts; providing that
19 the authorizations of State Debt in certain prior capital budgets and bond loan
20 acts be reduced by certain amounts; providing for certain additional information
21 to be detailed about each project in the capital program; repealing a requirement
22 for a certain appropriation; and generally relating to the financing of certain
23 capital projects.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
26 MARYLAND, That:

27 (1) The Board of Public Works may borrow money and incur indebtedness on
28 behalf of the State of Maryland through a State loan to be known as the Maryland
29 Consolidated Capital Bond Loan of 2004 in the total principal amount of
30 \$624,792,000. This loan shall be evidenced by the issuance, sale, and delivery of State
31 general obligation bonds authorized by a resolution of the Board of Public Works and
32 issued, sold, and delivered in accordance with Sections 8–117 through 8–124 of the
33 State Finance and Procurement Article and Article 31, Section 22 of the Code.

34 (2) The bonds to evidence this loan or installments of this loan may be sold as
35 a single issue of bonds under Section 8–122 of the State Finance and Procurement
36 Article.

37 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
38 and first shall be applied to the payment of the expenses of issuing, selling, and

1 delivering the bonds, unless funds for this purpose are otherwise provided, and then
2 shall be credited on the books of the Comptroller and expended, on approval by the
3 Board of Public Works, for the following public purposes, including any applicable
4 architects' and engineers' fees:

30 The resolution authorizing the issuance of said loan or any portion thereof shall
31 set forth in detail the dates when any of the bonds representing said loan or any
32 portion thereof are to be paid and the amount to be paid upon such dates, respectively.
33 The bonds issued pursuant to this Act, their transfer, the interest payable thereon,
34 and any income derived therefrom, including any profit realized in the sale or

11 SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly
12 declares that it is the public policy of this State to manage State general obligation
13 bond debt in a manner that will maintain Maryland's AAA bond rating. The General
14 Assembly further declares that legislative oversight, control, and review of all forms
15 of State obligations is essential to maintenance of the State's existing bond rating and
16 protection of the fiscal integrity of the State.

17 SECTION 4. AND BE IT FURTHER ENACTED, That, before work may
18 commence pursuant to any supplement to any appropriation contained in this Act,
19 satisfactory evidence must be given to the Board of Public Works that the project can
20 be completed with the aggregate of the funds in this Act and previously appropriated
21 for the stated purpose.

22 SECTION 5. AND BE IT FURTHER ENACTED, That, with the approval of
23 the Department of Budget and Management, any appropriation for construction
24 provided in this Act may be used to purchase capital equipment if the amount of the
25 appropriation exceeds the amount required for construction expenses, including
26 allowances for contingencies.

27 SECTION 6. AND BE IT FURTHER ENACTED, That, except as otherwise
28 provided in this Act, before a State agency or institution named in this Act as
29 responsible for an individual item may begin work with funds appropriated by this
30 Act, the agency or institution shall provide satisfactory evidence to the Board of
31 Public Works that the work described in the individual item can be completed with
32 the funds specified for that item.

33 SECTION 7. AND BE IT FURTHER ENACTED, That, with the approval of
34 the Department of Budget and Management, any appropriation under the provisions
35 of this Act that is in excess of the amount needed for a project may be credited to the
36 Construction Contingency Fund under Section 3-609 of the State Finance and
37 Procurement Article.

38 SECTION 8. AND BE IT FURTHER ENACTED, That, if federal funds are
39 available to help accomplish any project identified in this Act, the State agency or
40 institution responsible for the project shall make efforts through proper

1 administrative procedures to obtain these federal funds. Before spending any funds
2 appropriated by this Act, the agency or institution shall certify its efforts to the Board
3 of Public Works and state the reason for any failure to obtain federal funds. If federal
4 funds are obtained, they shall be used to defray the costs of the project described in
5 this Act and not to expand its scope.

6 SECTION 9. AND BE IT FURTHER ENACTED, That:

7 (a) for any appropriation for the planning of a State-owned project provided in
8 this Act, if a program required by Section 3-602(d) of the State Finance and
9 Procurement Article has not been submitted, the State agency or institution
10 responsible for the project shall submit a program to the Department of Budget and
11 Management for approval before funds may be expended from the appropriation; and

12 (b) for any appropriation for the construction of a State-owned project
13 provided in this Act, if preliminary plans and outline specifications required by
14 Section 3-602(f)(2)(i) of the State Finance and Procurement Article have not been
15 prepared, the State agency or institution responsible for the project shall submit
16 preliminary plans and outline specifications to the Department of Budget and
17 Management for approval before funds may be expended from the appropriation.

18 SECTION 10. AND BE IT FURTHER ENACTED, That no portion of the
19 proceeds of a loan or any of the matching funds provided for a project funded under
20 this Act may be used for the furtherance of sectarian religious instruction, or in
21 connection with the design, acquisition, construction, or equipping of any building
22 used or to be used as a place of sectarian religious worship or instruction, or in
23 connection with any program or department of divinity for any religious
24 denomination. Upon the request of the Board of Public Works, a recipient of the
25 proceeds of a loan under this Act shall submit evidence satisfactory to the Board that
26 none of the proceeds of the loan or any matching funds have been or are being used for
27 a purpose prohibited by this Act.

28 SECTION 11. AND BE IT FURTHER ENACTED, That:

29 (a) the Comptroller may advance funds from any loan fund account to any
30 other loan fund account established pursuant to a general obligation bond loan
31 enabling act, under the authority of which general obligation bonds have been issued,
32 for any expenditure authorized by that act; and

33 (b) with the approval of the Board of Public Works, the Comptroller may
34 advance funds to any loan fund account established pursuant to a general obligation
35 bond loan enabling act, for which an approving legal opinion has been received by the
36 Board, for any expenditure authorized by that act, provided that the next ensuing
37 sale of general obligation bonds shall include the issuance of bonds under the
38 authority of that act in an amount at least equivalent to the amount of the funds so
39 advanced.

40 SECTION 12. AND BE IT FURTHER ENACTED, That the net new debt to be
41 authorized by legislation in fiscal year 2004 may not exceed \$655,000,000, as
42 evidenced by the following:
