A BILL ENTITLED

1 AN ACT concerning

2 **Harford County - Alcoholic Beverages - Class A and Class D Licenses -**  
3 **Prohibition on Issuance**

4 FOR the purpose of prohibiting in Harford County certain alcoholic beverages  
5 licenses from being issued, except by way of renewal, to persons, corporations, or  
6 limited liability companies that hold an alcoholic beverages license in any other  
7 state or Washington, D.C.; and generally relating to alcoholic beverages licenses  
8 in Harford County.

9 BY repealing and reenacting, with amendments,  
10 Article 2B - Alcoholic Beverages  
11 Section 9-102(b-3)  
12 Annotated Code of Maryland  
13 (2001 Replacement Volume and 2003 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article 2B - Alcoholic Beverages**

17 9-102.

18 (b-3) (1) In Anne Arundel County, a Class A or Class D beer, beer and light  
19 wine, or beer, wine and liquor license may not be [issued] ISSUED, except by way of  
20 [renewal] RENEWAL, to a person, corporation, or limited liability company holding an  
21 alcoholic [beverage] BEVERAGES license in any other state, or Washington, D.C.

22 (2) In Baltimore City, a Class A or Class D beer, beer and light wine, or  
23 beer, wine and liquor license may not be [issued] ISSUED, except by way of [renewal]  
24 RENEWAL, to a person, corporation, or limited liability company holding an alcoholic  
25 [beverage] BEVERAGES license in any other state.

26 (3) In Baltimore County, a Class A or Class D beer, beer and light wine,  
27 or beer, wine and liquor license may not be issued, except by way of renewal, to a

1 person, corporation, or limited liability company holding an alcoholic beverages  
2 license in any other state or in Washington, D.C.

3           (4)       In Calvert County and St. Mary's County, a Class A or Class D beer,  
4 beer and light wine, or beer, wine and liquor license may not be issued, except by way  
5 of renewal, to a person, corporation, or limited liability company holding an alcoholic  
6 beverages license in any other state or in Washington, D.C.

7           (5)       In Charles County, a Class A or Class D beer, beer and light wine, or  
8 beer, wine and liquor license may not be issued, except by way of renewal, to a person,  
9 corporation, or limited liability company holding an alcoholic beverages license in any  
10 other state or in Washington, D.C.

11           (6)       IN HARFORD COUNTY, A CLASS A OR CLASS D BEER, BEER AND LIGHT  
12 WINE, OR BEER, WINE AND LIQUOR LICENSE MAY NOT BE ISSUED, EXCEPT BY WAY  
13 OF RENEWAL, TO A PERSON, CORPORATION, OR LIMITED LIABILITY COMPANY  
14 HOLDING AN ALCOHOLIC BEVERAGES LICENSE IN ANY OTHER STATE OR IN  
15 WASHINGTON, D.C.

16           [(6)]     (7)       In Washington County, a Class A or Class D beer, beer and light  
17 wine, or beer, wine and liquor license may not be issued, except by way of renewal, to  
18 a person, corporation, or limited liability company holding an alcoholic beverages  
19 license in any other state or in Washington, D.C.

20       SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 October 1, 2004.
