Board of Public Works - Reductions in Appropriations - Public Notice and Hearing Process

4 FOR the purpose of requiring the Board of Public Works to provide certain public

- 5 notice and hold a certain public hearing prior to approving a reduction in
- 6 appropriations; requiring the Board of Public Works to provide notice of
- 7 proposed reductions in appropriations to certain committees in the General
- 8 Assembly; requiring the Board of Public Works to publish certain public notices
- 9 in a certain number of publications of statewide circulation; requiring the
- 10 Department of Legislative Services to provide certain committees in the General

11 Assembly and the Board of Public Works with an analysis of certain proposed

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

20 MARYLAND, That the Laws of Maryland read as follows:

Article - State Finance and Procurement

22 7-213.

(a) [Except] SUBJECT TO THE PROVISIONS OF SUBSECTION (C) OF THIS
SECTION, AND EXCEPT as provided in subsection (b) of this section, with the approval
of the Board of Public Works, the Governor may reduce, by not more than 25%, any
appropriation:

27 (1) that the Governor considers unnecessary; or

1 (2) that is subject to budgetary reductions required under the budget bill 2 as approved by the General Assembly.

3 (b) (1) The Governor may not reduce an appropriation to the Legislative 4 Branch or the Judicial Branch of the State government.

- 5 (2) The Governor may not reduce an appropriation for:
- 6 (i) payment of the principal of or interest on the State debt;
- 7 (ii) public schools, including the Maryland School for the Deaf;
- 8 (iii) the Maryland School for the Blind; or
- 9 (iv) the salary of a public officer, during the term of office.
- 10 (3) Except as provided in § 8-109 of the State Personnel and Pensions
- 11 Article, the Governor may not reduce an appropriation for the salary of any
- 12 nontemporary employee in the State Personnel Management System.
- 13 (C) (1) PRIOR TO APPROVING THE REDUCTION OF ANY APPROPRIATIONS 14 UNDER THIS SECTION, THE BOARD OF PUBLIC WORKS SHALL:
- (I) PROVIDE AT LEAST A 30-DAY PUBLIC NOTICE AND AN
 INVITATION TO COMMENT ON THE PROPOSED REDUCTIONS IN APPROPRIATIONS TO
 THE LEGISLATIVE POLICY COMMITTEE, THE SENATE BUDGET AND TAXATION
 COMMITTEE, AND THE HOUSE APPROPRIATIONS COMMITTEE; AND
- (II) HOLD A PUBLIC HEARING NO EARLIER THAN 15 DAYS AFTER
 PROVIDING THE PUBLIC NOTICE REQUIRED UNDER SUBPARAGRAPH (I) OF THIS
 PARAGRAPH TO ALLOW FOR PUBLIC TESTIMONY ON THE PROPOSED REDUCTIONS IN
 APPROPRIATIONS.
- (2) THE PUBLIC NOTICE REQUIRED IN PARAGRAPH (1) OF THIS
 SUBSECTION SHALL BE PUBLISHED AT LEAST ONCE IN AT LEAST THREE
 NEWSPAPERS IN GENERAL CIRCULATION IN THE STATE AND SHALL INCLUDE:

(I) FOR EACH PROPOSED REDUCTION, A DETAILED DESCRIPTION
OF THE SOURCE AND NATURE OF THE BUDGETARY SAVINGS TO BE DERIVED AND AN
IMPACT STATEMENT DESCRIBING THE PROBABLE EFFECT ON PUBLIC SERVICES AND
THE POPULATIONS SERVED; AND

(II) THE TIME, DATE, AND LOCATION OF THE PUBLIC HEARING.

(3) WITHIN 15 DAYS AFTER THE PUBLIC NOTICE HAS BEEN PROVIDED
 UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE DEPARTMENT OF LEGISLATIVE
 SERVICES SHALL PREPARE AN ANALYSIS OF THE PRACTICAL AND FISCAL EFFECTS
 OF EACH OF THE PROPOSED REDUCTIONS IN APPROPRIATIONS AND, WHEN
 APPROPRIATE, ALTERNATIVES TO THE PROPOSED REDUCTIONS, FOR THE
 LEGISLATIVE POLICY COMMITTEE, THE SENATE BUDGET AND TAXATION
