- 18 WHEREAS, The economy of Maryland needs an educated workforce to be
- 19 competitive; and
- WHEREAS, An estimated 613,640 Maryland adults do not have a high school
- 21 diploma; and
- WHEREAS, High school dropouts who earn a high school diploma can earn an
- 23 extra \$7,000 in annual income; and
- 24 WHEREAS, The literacy level of a parent is the best predictor of a child's
- 25 literacy achievement; and
- 26 WHEREAS, The National Adult Literacy Survey reports that 20% of
- 27 Marylanders function at the lowest literacy level; and

- 9 established method of ongoing funding for adult education and literacy services.
