A BILL ENTITLED

1 AN ACT concerning

Vehicle Laws - Antitheft Provisions - Key Duplication and Possession

3 FOR the purpose of requiring a person who makes for another person a key capable of

- 4 operating the ignition of a motor vehicle to obtain the signature of and record
- 5 certain information concerning the individual requesting the key; requiring that
- 6 the signature and other recorded information be kept for a certain period of time
- 7 and made available to the Motor Vehicle Administration and to certain law
- 8 enforcement officers; providing for the application of certain provisions of this
- 9 Act; prohibiting an individual from possessing a key to the motor vehicle of
- 10 another with intent to violate a certain provision of law; prohibiting an
- 11 individual from duplicating a key to the motor vehicle of another without certain
- 12 permission; establishing certain penalties for violations of this Act; and
- 13 generally relating to the possession and duplication of motor vehicle keys.

- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 25 MARYLAND, That the Laws of Maryland read as follows:

3 4	(b) A person may not knowingly and willfully take a motor vehicle out of the owner's lawful custody, control, or use without the owner's consent.

	(2) THE REGISTRATION NUMBER, VEHICLE IDENTIFICATION NUMBER, YEAR, MAKE, MODEL, AND COLOR OF THE VEHICLE FOR WHICH THE KEY IS BEING MADE;

22 23	(C) FOR EACH KEY MADE, THE SIGNATURE AND ACCOMPANYING INFORMATION DESCRIBED IN SUBSECTION (B) OF THIS SECTION SHALL BE:
24 25	(1) KEPT FOR AT LEAST 2 YEARS AT THE LOCATION WHERE THE KEY WAS MADE; AND

32	(1) FOR A FIRST OFFENSE, \$500; OR
33	(2) FOR A SECOND OR SUBSEQUENT OFFENSE, \$1,000.

2 (A) AN INDIVIDUAL MAY NOT POSSESS A KEY TO THE MOTOR VEHICLE OF
3 ANOTHER WITH THE INTENT TO USE THE KEY TO VIOLATE § 7-105(B) OF THE
4 CRIMINAL LAW ARTICLE.

5 (B) AN INDIVIDUAL MAY NOT ATTEMPT TO DUPLICATE A KEY TO A MOTOR
6 VEHICLE WITHOUT PERMISSION FROM THE OWNER OR LAWFUL POSSESSOR OF THE
7 MOTOR VEHICLE.

8 (C) AN INDIVIDUAL WHO IS CONVICTED OF A VIOLATION OF ANY OF THE 9 PROVISIONS OF THIS SECTION IS SUBJECT TO A FINE OF NOT MORE THAN \$1,000 OR 10 IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR BOTH.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2004.
