23	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 3 (A) THIS SECTION APPLIES TO INDIVIDUAL, GROUP, OR BLANKET HEALTH
- 4 INSURANCE POLICIES AND CONTRACTS DELIVERED OR ISSUED FOR DELIVERY IN
- 5 THE STATE BY INSURERS, NONPROFIT HEALTH SERVICE PLANS, AND HEALTH
- 6 MAINTENANCE ORGANIZATIONS.
- 7 (B) Notwithstanding any other provision of an individual, group, or blanket
- 8 health insurance policy OR CONTRACT SUBJECT TO THIS SECTION, if the policy OR

- 33 effect October 1, 2004.
