CHAPTER _____

1 AN ACT concerning

2 **State Boat Act - Waterway Improvement Fund - Authorized Uses**

3 FOR the purpose of altering the amount of certain funds that may be proposed to be
4 used by the Natural Resources Police for marine operations for certain fiscal
5 years; repealing a provision that requires a certain payment to the Comptroller;
6 repealing the authority of the Department of Natural Resources to use certain
7 funds for enforcement of the State Boat Act; providing for a delayed effective
8 date; and generally relating to the enforcement of the State Boat Act.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
8 MARYLAND, That the Laws of Maryland read as follows:

9 **Article - Natural Resources**

10 8-709.

11 (a) The Department shall include in its annual budget request an itemized list
12 of requests for the use of any available money from the Waterway Improvement Fund
13 for the projects under § 8-707 of this subtitle. The Department's list shall include a
14 brief description of each project, an estimate of its cost, and the benefits to be derived
15 from it. The list shall designate which projects are financed solely by the Waterway
16 Improvement Fund, which are matching fund projects, and which are interest-free
17 loan projects.

18 [(c) Notwithstanding the provisions of subsection (a) of this section, the
19 Department may propose in its annual budget, beginning with the fiscal year 1994
20 budget, an appropriation of not more than \$1,000,000 from the Waterway
21 Improvement Fund to support marine operations in the Natural Resources Police.]

22 (C) NOTWITHSTANDING THE PROVISIONS OF SUBSECTION (A) OF THIS
23 SECTION, THE DEPARTMENT MAY PROPOSE AN APPROPRIATION FROM THE
24 WATERWAY IMPROVEMENT FUND TO SUPPORT MARINE OPERATIONS OF THE
25 NATURAL RESOURCES POLICE NOT EXCEEDING:

26 (1) ~~\$1,500,000~~ \$1,700,000 IN THE DEPARTMENT'S FISCAL YEAR 2006
27 BUDGET; AND

28 (2) \$2,000,000 IN THE DEPARTMENT'S FISCAL YEAR 2007 BUDGET, AND
29 EVERY YEAR THEREAFTER.

31 [(h) Notwithstanding the provisions of § 8-723 of this subtitle, the Department
32 shall deposit \$225,000 of funds from the excise tax levied under this section with the
33 Comptroller of the Treasury in the General Fund, and the balance in excess of
34 \$225,000 with the Comptroller of the Treasury in the Waterway Improvement Fund
35 to be expended only for the purposes specified.]

36 [(i) (H) If the Department determines there has been an overpayment of the
37 tax on a vessel, or an overpayment has resulted for any other reason, the Department

1 may submit the overpayment and supporting data whether accompanied by a written
2 claim or not to the State Comptroller for refund to the appropriate person.

3 [(j) Notwithstanding any other provision of this section, the Department shall
4 deposit, in accordance with the provisions of § 8-723 of this subtitle, up to \$350,000 of
5 funds from the excise tax levied under this section and as appropriated in the State
6 budget, to be used for enforcement of the State Boat Act, including collection of the
7 excise tax levied under this section.]

8 [(k) (I) (1) For purposes of subsection (a)(3) of this section, a vessel is
9 deemed to be held for maintenance or repair if:

10 (i) The maintenance or repair work is provided in exchange for
11 compensation;

12 (ii) The maintenance or repair work is performed pursuant to a
13 schedule preestablished with one or more marine contractors; and

14 (iii) The total cost of the maintenance or repair work is at least two
15 times the reasonable current market cost of docking or storing the vessel.

16 (2) Time spent conducting sea trials shall be included when calculating
17 the period of time a vessel is held for maintenance or repair under subsection (a)(3) of
18 this section.

20 (a) Any fee and other revenue the Department collects under authority of this
21 subtitle, and any other available income, shall be deposited in the State Treasury and
22 used exclusively for the administration, functions, and objectives of this subtitle.
23 These funds are credited to the Department.

24 (b) The Department may use the funds credited to its accounts to purchase,
25 rent, and operate any equipment necessary to accomplish the purposes of this
26 subtitle, within budgetary limitations.

27 (c) Subject to available income, the Department may employ necessary
28 personnel subject to the provisions of the State Personnel and Pensions Article.

29 (d) Within the limits of funds available, the Department may enter into any
30 agreement with the federal government, any municipality or other political
31 subdivision of the State, or any private agency to share the cost of any development,
32 construction, or improvement of waterways or of facilities determined to have
33 beneficial value to the boating public.

34 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
35 ~~October 1, 2004~~ July 1, 2005.
