2 Public Health - Drug Abuse Treatment Programs - Zoning

- 3 FOR the purpose of authorizing certain drug abuse treatment programs to locate in
- 4 certain zoning areas; prohibiting the subjection of certain drug abuse treatment
- 5 programs to certain exceptions, permits, or procedures; providing for the
- 6 resolution of certain conflicts; defining certain terms; and generally relating to
- 7 the zoning of drug abuse treatment programs that administer medication as
- 8 treatment.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:
- 16 Article Health General
- 17 8-406.
- 18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 19 INDICATED.
- 20 (2) "DRUG ABUSE TREATMENT PROGRAM" HAS THE MEANING STATED IN
- 21 § 8-403 OF THIS SUBTITLE.
- 22 (3) "HEALTH CARE PRACTITIONER" MEANS ANY INDIVIDUAL WHO IS
- 23 LICENSED, CERTIFIED, OR OTHERWISE AUTHORIZED UNDER THE HEALTH
- 24 OCCUPATIONS ARTICLE TO PROVIDE HEALTH CARE SERVICES.
- 25 (B) A DRUG ABUSE TREATMENT PROGRAM THAT ADMINISTERS
- 26 PHARMACOLOGICAL INTERVENTIONS INCLUDING METHADONE AND LAAM TO
- 27 PROVIDE TREATMENT, SUPPORT, AND RECOVERY TO OPIOID-ADDICTED PATIENTS

- 1 MAY LOCATE IN THE SAME ZONING AREA AS AN OFFICE FOR ONE OR MORE HEALTH
- 2 CARE PRACTITIONERS THAT PROVIDE OUTPATIENT TREATMENT.
- 3 (C) A DRUG ABUSE TREATMENT PROGRAM UNDER SUBSECTION (B) OF THIS
- 4 SECTION MAY NOT BE SUBJECT TO ANY SPECIAL EXCEPTION, CONDITIONAL USE
- 5 PERMIT, OR PROCEDURE THAT DIFFERS FROM THAT REQUIRED FOR AN OFFICE FOR
- 6 ONE OR MORE HEALTH CARE PRACTITIONERS THAT PROVIDES OUTPATIENT
- 7 TREATMENT.
- 8 (D) A GENERAL ZONING ORDINANCE, RULE, OR REGULATION OF A POLITICAL
- 9 SUBDIVISION THAT CONFLICTS WITH THE PROVISIONS OF THIS SECTION OR A RULE
- 10 OR REGULATION THAT CARRIES OUT THE PURPOSE OF THIS SECTION IS
- 11 SUPERSEDED BY THIS SECTION TO THE EXTENT OF A CONFLICT.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 13 effect October 1, 2004.
