- 22 (B) A PERSON COVERED UNDER THIS SECTION MAY NOT:
- 23 (1) SELL OR SHIP CIGARETTES, ORDERED OR PURCHASED THROUGH A

- 10 (2) A PERSON OTHER THAN A LICENSEE WHO SELLS OR SHIPS
- 11 CIGARETTES IN VIOLATION OF THIS SECTION OR CAUSES CIGARETTES TO BE
- 12 SHIPPED IN VIOLATION OF THIS SECTION IS SUBJECT TO THE PENALTY SPECIFIED
- 13 UNDER § 13-1015 OF THE TAX GENERAL ARTICLE.
