BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 16 MARYLAND, That the Laws of Maryland read as follows: 17 **Article - State Finance and Procurement** 18 14-407. 19 (A) (1) IN THIS SECTION THE FOLLOWING WORKS HAVE THE MEANINGS 20 INDICATED. 21 "ILEV VEHICLE" MEANS AN INHERENTLY LOW EMISSION VEHICLE AS 22 DEFINED IN, AND CONFORMING TO THE CERTIFICATION AND LABELING 23 REQUIREMENTS OF, FEDERAL REGULATIONS UNDER 40 C.F.R. PART 88. "POLITICAL SUBDIVISION" MEANS: 24 (3)

- 1 (4) "QUALIFIED HYBRID VEHICLE" HAS THE MEANING STATED IN § 2 13-815 OF THE TRANSPORTATION ARTICLE.
- 3 (B) IN FISCAL YEAR 2005 AND EACH FISCAL YEAR THEREAFTER, THE STATE
- 4 AND EACH POLITICAL SUBDIVISION OF THE STATE THAT PURCHASES VEHICLES
- 5 SHALL ENSURE THAT AT LEAST 15% OF THE NEW PASSENGER CARS, LIGHT TRUCKS,
- 6 AND BUSES PURCHASED DURING THE FISCAL YEAR ARE EITHER ILEV VEHICLES OR
- 7 QUALIFIED HYBRID VEHICLES.
- 8 (C) THIS SECTION DOES NOT APPLY TO A CONTRACT OR PROCUREMENT
- 9 AGREEMENT IN EFFECT ON JULY 1, 2004.
- SECTION 2. AND BE IT FURTHER ENACTED, That, the Secretary of Budget
- 11 and Management, with respect to vehicle purchases by the State, and the local
- 12 governing body of each political subdivision, with respect to vehicle purchases by the
- 13 political subdivision, shall submit to the General Assembly, in accordance with §
- 14 2-1246 of the State Government Article, on or before September 1, 2005, and on or
- 15 before September 1 each year thereafter, a report detailing compliance with this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2004.
