- 4 FOR the purpose of requiring the Motor Vehicle Administration to develop and make
- 5 available a special registration plate honoring veterans of Operation Iraqi

- 21 (A) THE ADMINISTRATION SHALL DEVELOP AND MAKE AVAILABLE FOR
- 22 QUALIFYING VEHICLES A SPECIALLY DESIGNED REGISTRATION PLATE HONORING
- 23 VETERANS OF OPERATION IRAQI FREEDOM.
- 24 (B) (1) THE OWNER OF A MOTOR VEHICLE, OR A LESSEE OF THE VEHICLE
- 25 UNDER A LEASE NOT INTENDED AS SECURITY, OR A DIRECTOR, OFFICER, EMPLOYEE,
- 26 OR PARTNER OF A BUSINESS ENTITY THAT OWNS THE VEHICLE MAY APPLY TO THE
- 27 ADMINISTRATION FOR AN ORIGINAL OR SUBSTITUTE REGISTRATION PLATE UNDER
- 28 THIS SECTION IF THE VEHICLE IS INCLUDED IN ONE OF THE FOLLOWING CLASSES:

- 15 SECTION SHALL PAY A FEE AS DETERMINED BY THE ADMINISTRATION EACH TIME

- THE ADDITIONAL FEE SHALL BE CALCULATED TO RECOVER THE 17 (2) 18 COSTS INCURRED BY THE ADMINISTRATION IN CARRYING OUT THE PROVISIONS OF 19 THIS SECTION.
- 20 THE ADDITIONAL FEE COLLECTED UNDER THIS SECTION IS NOT (3) 21 REQUIRED FOR SPECIAL REGISTRATION OF A VEHICLE THAT IS:

- 23 OWNED OR LEASED BY A VETERAN OF OPERATION IRAQI (II)
- 24 FREEDOM WHO HAS RETURNED FROM ACTIVE MILITARY DUTY IN IRAO IN THE
- 25 PREVIOUS 2 YEARS.
- NO PORTION OF THE FEE COLLECTED UNDER THIS SECTION MAY BE
- 27 CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR
- 28 DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.
- THE ADMINISTRATION SHALL ADOPT REGULATIONS TO COVER THE 29
- 30 ISSUANCE OF SPECIAL REGISTRATION PLATES UNDER THIS SECTION.
