- 17 OF THIS PARAGRAPH, THE Sheriff of Dorchester County shall receive an annual
- 18 salary of \$45,000 and be allowed the actual operating costs of the Sheriff's office,
- 19 including the maintenance of automobiles.
- 20 (II) FOR THE CALENDAR YEARS 2006 THROUGH 2009, THE SHERIFF OF
- 21 DORCHESTER COUNTY SHALL RECEIVE AN ANNUAL SALARY THAT EQUALS 75% OF
- 22 THE SALARY PROVIDED FOR THE STATE'S ATTORNEY OF DORCHESTER COUNTY

- 24 (III) FOR CALENDAR YEAR 2010 AND THEREAFTER, THE SHERIFF OF

- 27 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
- 28 35 of the Maryland Constitution, this Act may not be construed to extend or apply to

- 1 the salary or compensation of the Sheriff of Dorchester County in office on the2 effective date of this Act, but the provisions of this Act concerning the salary or
- 3 compensation of the Sheriff of Dorchester County shall take effect at the beginning of
- 4 the next following term of office.
- 5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 2004.
