CHAPTER _____

1 AN ACT concerning

2 **Dorchester County - Sheriff - Salary**

3 FOR the purpose of establishing the salary for the Sheriff of Dorchester County for
4 certain calendar years; providing that this Act does not apply to the salary or
5 compensation of the incumbent Sheriff of Dorchester County; and generally
6 relating to the salary of the Sheriff of Dorchester County.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Courts and Judicial Proceedings**

15 2-309.

16 (k) (1) (I) [The] EXCEPT AS PROVIDED IN ~~SUBPARAGRAPHS (II) AND (III)~~
17 SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE Sheriff of Dorchester County shall
18 receive an annual salary of \$45,000 and be allowed the actual operating costs of the
19 Sheriff's office, including the maintenance of automobiles.

20 (II) ~~FOR THE CALENDAR YEARS 2006 THROUGH 2009, THE SHERIFF~~
21 ~~OF DORCHESTER COUNTY SHALL RECEIVE AN ANNUAL SALARY THAT EQUALS 75% OF~~

1 ~~THE SALARY PROVIDED FOR THE STATE'S ATTORNEY OF DORCHESTER COUNTY~~
2 ~~DURING THOSE YEARS.~~

3 (H) ~~FOR CALENDAR YEAR 2010 AND THEREAFTER, THE SHERIFF OF~~
4 ~~DORCHESTER COUNTY SHALL RECEIVE THE SAME ANNUAL SALARY AS WAS PAID IN~~
5 ~~2009 A SALARY OF:~~

- 6 1. \$62,500 FOR CALENDAR YEAR 2006;
7 2. \$63,500 FOR CALENDAR YEAR 2007;
8 3. \$64,500 FOR CALENDAR YEAR 2008; AND
9 4. \$65,500 FOR EACH SUBSEQUENT CALENDAR YEAR.

10 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
11 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
12 the salary or compensation of the Sheriff of Dorchester County in office on the
13 effective date of this Act, but the provisions of this Act concerning the salary or
14 compensation of the Sheriff of Dorchester County shall take effect at the beginning of
15 the next following term of office.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2004.
