- 2 Creation of a State Debt Wicomico County Boulevard Theatre Performing
 Arts Complex
- 4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$500,000,
- 5 the proceeds to be used as a grant to the Board of Directors of the Salisbury
- 6 Wicomico Arts Council, Inc. for certain development or improvement purposes;
- 7 providing for disbursement of the loan proceeds, subject to a requirement that
- 8 the grantee provide and expend a matching fund; establishing a deadline for the
- 9 encumbrance or expenditure of the loan proceeds; requiring the grantee to grant
- and convey a certain easement to the Maryland Historical Trust; and providing
- generally for the issuance and sale of bonds evidencing the loan.
- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That:
- 14 (1) The Board of Public Works may borrow money and incur indebtedness on
- 15 behalf of the State of Maryland through a State loan to be known as the Wicomico
- 16 County Boulevard Theatre Performing Arts Complex Loan of 2004 in a total
- 17 principal amount equal to the lesser of (i) \$500,000 or (ii) the amount of the matching
- 18 fund provided in accordance with Section 1(5) below. This loan shall be evidenced by
- 19 the issuance, sale, and delivery of State general obligation bonds authorized by a
- 20 resolution of the Board of Public Works and issued, sold, and delivered in accordance
- 21 with §§ 8-117 through 8-124 of the State Finance and Procurement Article and
- 22 Article 31, § 22 of the Code.
- 23 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 24 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 25 § 8-122 of the State Finance and Procurement Article.
- 26 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 27 and first shall be applied to the payment of the expenses of issuing, selling, and
- 28 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 29 shall be credited on the books of the Comptroller and expended, on approval by the
- 30 Board of Public Works, for the following public purposes, including any applicable
- 31 architects' and engineers' fees: as a grant to the Board of Directors of the Salisbury
- 32 Wicomico Arts Council, Inc. (referred to hereafter in this Act as "the grantee") for the

- 1 design, construction, renovation, reconstruction, and capital equipping of the
- 2 Boulevard Theatre to be converted into a performing arts complex, located in
- 3 Salisbury.
- 4 (4) An annual State tax is imposed on all assessable property in the State in
- 5 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 6 when due and until paid in full. The principal shall be discharged within 15 years
- 7 after the date of issuance of the bonds.
- 8 (5) Prior to the payment of any funds under the provisions of this Act for the
- 9 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 10 matching fund. No part of the grantee's matching fund may be provided, either
- 11 directly or indirectly, from funds of the State, whether appropriated or
- 12 unappropriated. The fund may consist of real property, in kind contributions, or funds
- 13 expended prior to the effective date of this Act. In case of any dispute as to the amount
- 14 of the matching fund or what money or assets may qualify as matching funds, the
- 15 Board of Public Works shall determine the matter and the Board's decision is final.
- 16 The grantee has until June 1, 2006, to present evidence satisfactory to the Board of
- 17 Public Works that a matching fund will be provided. If satisfactory evidence is
- 18 presented, the Board shall certify this fact and the amount of the matching fund to
- 19 the State Treasurer, and the proceeds of the loan equal to the amount of the matching
- 20 fund shall be expended for the purposes provided in this Act. Any amount of the loan
- 21 in excess of the amount of the matching fund certified by the Board of Public Works
- 22 shall be canceled and be of no further effect.
- 23 (6) The proceeds of the loan must be expended or encumbered by the Board of
- 24 Public Works for the purposes provided in this Act no later than June 1, 2011. If any
- 25 funds authorized by this Act remain unexpended or unencumbered after June 1, 2011,
- 26 the amount of the unencumbered or unexpended authorization shall be canceled and
- 27 be of no further effect. If bonds have been issued for the loan, the amount of
- 28 unexpended or unencumbered bond proceeds shall be disposed of as provided in §
- 29 8-129 of the State Finance and Procurement Article.
- 30 (7) (a) Prior to the issuance of the bonds, the grantee shall grant and convey
- 31 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 32 its interest:
- 33 (i) On the land or such portion of the land acceptable to the Trust;
- 34 and
- 35 (ii) On the exterior and interior, where appropriate, of the historic
- 36 structures.
- 37 (b) If the grantee or beneficiary of the grant holds a lease on the land
- 38 and structures, the Trust may accept an easement on the leasehold interest.
- 39 (c) The easement must be in form and substance acceptable to the Trust
- 40 and any liens or encumbrances against the land or the structures must be acceptable
- 41 to the Trust.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 June 1, 2004.
