BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 16 MARYLAND, That the Laws of Maryland read as follows: 17 **Article - Health - General** 18 8-406. THIS SECTION APPLIES ONLY IN HOWARD COUNTY. 19 (A) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 20 (B) (1) 21 INDICATED.

23 TREATMENT PROGRAM THAT ADMINISTERS METHADONE IN THE TREATMENT,

24 MAINTENANCE, OR DETOXIFICATION OF INDIVIDUALS.

25 (3) "NOTIC 26 GENERAL CIRCULATION.

"METHADONE TREATMENT FACILITY" MEANS A DRUG ABUSE

"NOTICE" MEANS PUBLICATION IN A LOCAL NEWSPAPER OF

- 1 (C) THIS SECTION DOES NOT APPLY TO A METHADONE TREATMENT FACILITY 2 THAT WAS CERTIFIED BY THE DEPARTMENT PRIOR TO MAY 1, 2004.
- 3 (D) A METHADONE TREATMENT FACILITY MAY NOT BE ESTABLISHED OR 4 OPERATED WITHIN 1,000 FEET OF AN EXISTING:
- 5 (1) SCHOOL; OR
- 6 (2) RESIDENTIAL HOUSING AREA.
- 7 (E) (1) NOTWITHSTANDING SUBSECTION (D) OF THIS SECTION, IF THE 8 COUNTY GOVERNING BODY, BY RESOLUTION OR ORDINANCE, APPROVES THE
- 9 ESTABLISHMENT OR OPERATION OF THE METHADONE TREATMENT FACILITY AT THE
- 10 PROPOSED LOCATION IN ACCORDANCE WITH THE PUBLIC HEARING PROVISIONS IN
- 11 PARAGRAPH (2) OF THIS SUBSECTION, THEN THE METHADONE TREATMENT FACILITY
- 12 MAY BE ESTABLISHED OR OPERATED AT THAT LOCATION.
- 13 (2) (I) AT LEAST 21 DAYS BEFORE A VOTE ON A RESOLUTION OR
- 14 ORDINANCE UNDER PARAGRAPH (1) OF THIS SUBSECTION, OR PRIOR TO THE
- 15 ESTABLISHMENT OR OPERATION OF A METHADONE TREATMENT FACILITY, THE
- 16 COUNTY GOVERNING BODY SHALL HOLD ONE OR MORE PUBLIC HEARINGS
- 17 REGARDING THE LOCATION OF THE PROPOSED METHADONE TREATMENT FACILITY.
- 18 (II) AT LEAST 30 DAYS PRIOR TO A PUBLIC HEARING HELD UNDER
- 19 THIS PARAGRAPH, THE PROPONENTS OF THE METHADONE TREATMENT FACILITY
- 20 SHALL GIVE NOTICE OF THE HEARING TO ALL OWNERS OF REAL PROPERTY LOCATED
- 21 WITHIN 1,000 FEET OF THE PROPOSED LOCATION.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 June 1, 2004.
